STANDARD PRE-QUALIFICATION REQUIREMENT

Prime contractors must pre-qualify with The Department of Transportation in accordance with Tennessee Code Annotated 54-5-117, before bid authorization for highway contracts will be granted. PROSPECTIVE BIDDERS MUST HAVE FILED THEIR QUESTIONNAIRES FOR QUALIFICATIONS AT LEAST FOURTEEN (14) DAYS PRECEDING THE DATE OF LETTING.

MANDATORY PRE-BID MEETING

Prime/joint venture contractors must participate in a pre-bid meeting to be held on June 9, 2021 from 10:30 A.M. – 11:30 A.M., CST via remote conferencing. Participation in the remote conference is mandatory as part of these special pre-qualification requirements for prime contractors. Subcontractors are encouraged to participate but will be permitted to work as a subcontractor on this project if unable to attend. If you are bidding as a prime/joint venture or are a subcontractor wishing to participate, please send an email to ryan.sweeney@tn.gov. Emails will be received until June 9, 2021, at 9:00 AM, CST. Emails received after 9:00 AM, CST, will not be considered, and participants will be ineligible to participate in the meeting.

All prime/joint venture contractors pre-qualified by the Department must obtain authorization to bid through the standard bid authorization procedure. BID AUTHORIZATION MUST BE OBTAINED PRIOR TO 4:00 P.M. CST ON THE DAY PRECEDING THE LETTING.
