The Construction Division of the Tennessee Department of Transportation (TDOT), an Equal Opportunity Affirmative Action Employer, is seeking to retain the services of Design-Builders for **Interstate 75 Interchange AT Interstate 24, Hamilton County Tennessee**, with experience in the following, but is not limited to:

1. Bridge Design;
2. Interchange and ramp reconstruction under traffic;
