We request that the section (f) requirement be waived.	Section C - Contents of SOQs Paragraph 2.d.1.f Design-Build Project Manager Will be revised by addendum to state: <i>(f)Should have at least ten (10) years (15 preferred) of experience managing projects of similar scope and magnitude, or five (5) years (10 preferred) of experience managing projects of similar scope and magnitude if he/she is a registered professional engineer in the state of Tennessee.</i>
