

## **NOTICE OF PUBLIC HEARING and NOTICE OF AVAILABILITY OF THE APPROVED ENVIRONMENTAL DOCUMENT**

The Tennessee Department of Transportation (TDOT) will conduct a National Environmental Policy Act (NEPA) and Design Public Hearing on Thursday, March 25, 2010 to discuss the Interstate 40 Interchange at SR-196 (Hickory Withe Road) in Fayette, County. The meeting will be held from 5:00 PM to 7:00 PM at the Oakland Elementary School, 14925 Highway 194 North, Oakland, TN.

This NEPA/Design Public Hearing is being held in order to provide the public an opportunity to provide input on the approved Environmental Assessment (EA) prior to completion of the final environmental document and an opportunity to provide input on the design of the proposed interchange. A brief presentation will be followed by a question and answer period. Representatives from TDOT will be present to address questions pertaining to the general layout and design of the proposed new interchange, along with the social, economic, and environmental impacts associated with it. TDOT will also have representatives available to discuss the steps that will occur following the completion of the environmental phase of the project, including answering questions on the right-of-way acquisition process.

Two alternatives were evaluated in the EA, the No-Build Alternative and one Build Alternative. The No-Build Alternative would mean that no new interchange would be constructed at I-40 and SR-196. Secondary roadways would continue to be used to distribute traffic to the nearest existing interchanges located to the east and west of SR-196. The Build Alternative would result in construction of a new grade-separated interchange at I-40 and SR-196 and would provide improved access to the interstate for nearby communities and surrounding areas, including Arlington and Gallaway to the north, and Hickory Withe and Oakland to the south.

The EA was approved by the Federal Highway Administration on January 25, 2010.
