TDOT is pleased to announce the redistribution of FTA Section 5307 FFY2015 program funds with this split allocation letter in order to enable Tennessee's small urban agencies to apply directly to the FTA for the 5307 funds. The redistribution is determined by Director's Discretion. Results are shown below.

As identified in this Split Letter, the Designated Recipient authorizes the assignment/allocation of Section 5307 to the Direct Recipient(s) named herein. The undersigned agree to the Split Letter and the amounts allocated/assigned to each Direct Recipient. Each Direct Recipient is responsible for its application to the

Federal Transit Administration to receive Section 5307 funds and assumes the responsibilities associated with any award for these funds.

All agencies are required to obligate their allocated 5307 redistributed funds in TrAMS by December 31, 2018. Unobligated funds will be redistributed based on Director's Discretion. TDOT Multimodal offers a state match on 5307 capital expenses only.

Tennessee 5307 funds are in high demand across the state and TDOT wants to ensure every \$1 is utilized for public transit service and that discarding any funds back to the FTA is minimized. Direct Recipients must receive approval from TDOT prior to deobligating funds in their active 5307 grants. In the event that funds are deobligated by a direct recipient without TDOT written approval, funds may be deducted from the agency's future 5307 allocations.
