#### Firm Name

<u>Proposed Indirect Cost Rate</u> – This is rate calculated based on your self-prepared indirect cost rate schedule. If you need guidance on preparing your indirect cost rate schedule, there is an example schedule on the TDOT webpage. There is also an AASHTO guide on the TDOT webpage. <u>Date of Proposal Preparation</u> – This is the date that you complete the indirect cost rate schedule.

<u>Fiscal Period Covered</u> (mm/dd/yyyy to mm/dd/yyyy) – This is the fiscal period covered in the self-prepared indirect cost rate schedule. The indirect cost rate is based on actual historical data. So, if you are preparing your schedule today and your fiscal year end is December 31, the most recent historical fiscal period covered would be 01/01/2018-12/31/2018.
