Q1. There is an existing fire hydrant at station 108+55 +/- . Who will extend it to behind the curb line? Don't see a provision on the bid form for relocating it.

A1. The existing fire hydrant will be relocated by MLG&W and is not the responsibility of the contractor.

Q2. Is the 5% DBE goal still required for this project? TDOT removed it from their bid requirement at the last bid opening.

A2. Per coordination with TDOT, the DBE goal has been removed from this project. The proposal contract Cover and Table of Contents pages have been updated to remove the DBE goal and remove SP 1247LG from the document. The bid opening date has also been extended to Tuesday, October 14th, 2025 at 2:00 PM.
