PROJECT DESCRIPTION

This project is located within the City of Red Bank, TN and involves the resurfacing of Dayton Boulevard from Browntown Road to Gadd Road. The scope of work includes traffic control, asphalt milling, asphalt resurfacing, replacement of traffic signal loop detectors, signage, and pavement markings. The total project length is approximately 3,953 LF, or 0.75 miles.

PROPOSAL CONTRACTS WILL BE ISSUED UNTIL THE TIME SET FOR OPENING BIDS

A Prime Contractor must prequalify with the Department of Transportation in accordance with Section 54-5-117 of the "Tennessee Code Annotated" and Tennessee Department of Transportation Rule 1680-5-3 prequalification of contractors before biddable proposals will be furnished.
