**PROJECT DESCRIPTION**

THIS PROJECT INVOLVES ADDING NEW TRAFFIC SIGNAL AT THE INTERSECTION OF MOORESVILLE HIGHWAY (SR373) AND W. ELLINGTON PARKWAY (SR417), ALONG WITH ADDING COMPLIANT CURBRAMPS AND STRIPING TO MULTIPLE STREET SEGMENTS THROUGHOUT THE CITY OF LEWISBURG. THE IMPROVEMENTS INCLUDE MULTIPLE SIGNAL POLES, CURBRAMPS, CROSSWALKS AND ROADWAY STRIPING TO IMPROVE TRAFFIC FLOW AND PEDESTRIAN AWARENESS. THE TOTAL PROJECT LENGTH IS 0.094 MILES.
