PROJECT DESCRIPTION

THIS PROJECT INVOLVES UPGRADES AT FOURTEEN (14) TRAFFIC SIGNALS ALONG LONG HOLLOW PIKE, MAIN STREET AND CONFERENCE DRIVE. PROJECT ELEMENTS INCLUDE THE RECONSTRUCTION OF FOUR (4) INTERSECTIONS, TRAFFIC SIGNAL INFRASTRUCTURE UPGRADES, VIDEO VEHICLE DETECTION, ADA-COMPLIANT CURB RAMPS, AND SIGNING AND MARKING. THE TOTAL PROJECT LENGTH IS 3.560 MILES.
