PROJECT DESCRIPTION

This project involves asphalt resurfacing, curb & gutter, sidewalks, storm sewer, median installation, pedestrian signalization for mid-block crossing, streetscape improvements, and relocation of light poles along SR-1 (US-70, E. Magnolia Avenue) from N. Bertrand Street to N. Kyle Street. The project length is 0.22 miles.
