PROJECT DESCRIPTION

This project involves construction of new sidewalk facilities along SR-1 (Dr. Martin Luther King Jr. Blvd) from Middle Tennessee Blvd to near Apollo Dr. The project length is 0.623 miles. Project also includes curb upgrades and traffic signal modifications at one intersection. The proposal contract specifies a completion time of on or before 365 calendar days.
