

NOTICE TO CONSULTANT REAL ESTATE APPRAISERS REGARDING A REQUEST FOR LETTERS OF INTEREST AND QUALIFICATIONS**October 6, 2021**

The City of Franklin, Tennessee, an Equal Opportunity, Affirmative Action Employer, seeks to retain the services of professional consultant real estate appraisers, licensed to conduct appraisals in Tennessee, for the **federally and state funded Right-of-Way Phase of the Columbia Avenue Widening and Improvements Project (TDOT PIN 121454.00)**. Consultant services include the performance of right-of-way (ROW) Real Estate Appraisals and other services for approximately 60 properties along Columbia Avenue (US-31/SR-6), from Mack Hatcher Parkway (SR-397) to Downs Boulevard, to allow for the widening of the existing 3-lane roadway to 5 travel lanes with sidewalks. The project shall be accomplished in accordance with all applicable Federal (i.e. FHWA) and State (i.e. TDOT Local Programs) rules, regulations, and guidelines. The consultant firm must be on TDOT's pre-approved list or have a completed pre-qualification form filed with TDOT by the deadline for the Letters of Interest. The prequalified firm must have unlimited status. Responsibilities of the professional consultant firm include, but are not limited to:

Required Scope of Services

- Perform right-of-way (ROW) real estate appraisals as primary project Appraiser.
- Perform real estate appraisal reviews as project Review Appraiser (if not selected as primary project Appraiser).
- Prepare for and participate in required Pre-Trial Conferences, Depositions, and Court Testimonies.
- Attend any public meetings that may be required.
- Draft all appraisal documents following TDOT and City of Franklin standards.
- Coordination with appraisers, review appraisers, negotiators, closing agents, and City & TDOT staff.
- Establish and maintain a project file with all applicable documentation for each tract.

Estimated Schedule for Performance of Work

- Initial round of completed appraisals to be delivered to the City: Spring 2022
- Final round of completed appraisals to be delivered to the City: Spring 2023
- All real property interests acquired by others, and orders of possession obtained through condemnation: Fall 2023

Firms may request consideration by submitting a Letter of Interest (LOI) in a sealed envelope that is clearly marked "LOI for Real Estate Appraisal Services for the Columbia Avenue Widening & Improvements Project (PIN 121454.00)" to **the City of Franklin, Engineering Department, 109 3rd Avenue South, Suite 133, Franklin, TN 37064 Attn: William Banks**, or by submitting via e-mail to William.Banks@FranklinTN.gov. The LOI shall indicate the scope of services to be completed and any sub-consultants to be utilized. All LOIs must be received by the **City of Franklin** on or before **2:00 PM (Central Daylight Time), Tuesday, November 2, 2021**. **Late submissions will not be considered.** Method of payment for the contract will be lump sum (invoiced monthly as work is completed).

Phase 1 Evaluation

For the Phase 1 evaluation, firms shall submit LOIs with firm contact information, including: name, title, address, phone number, and e-mail of primary contact. The LOIs shall be limited to a *maximum* of five (5), single-sided, 8.5" x 11" pages with a *minimum* font size of 10. Each mailed LOI submittal shall include: one (1) printed copy and one (1) digital copy (e.g. PDF on a CD, flash drive, etc.). A single digital copy (e.g. PDF file) will suffice if emailed. The LOIs shall also include:

- Experience with Right-of-Way (ROW) Appraisals and Acquisition on federally and/or state funded transportation projects,
- Specialized expertise related to requested ROW services,
- Relevant professional licensures and certifications, and
- TDOT prequalification status.

From the LOIs, the **City of Franklin** will select three (3) qualified firms to submit qualifications for a Phase 2 Evaluation. From this list the top ranked consultant(s) will be selected.

Phase 2 Evaluation

The **City of Franklin** will evaluate the top three (3) firms on the following criteria (relative weight):

- Experience with Right-of-Way (ROW) Appraisals and Acquisition on federally and/or state funded transportation projects, specifically TDOT Local Programs projects (20%),
- Qualifications and availability of proposed staff (20%),
- Demonstrated ability to perform the work efficiently and meet schedules without compromising sound professional practices and compliance with TDOT's Right-of-Way Manual and the Uniform Relocation Assistance and Real Properties Acquisition Policies Act, 42 U.S.C. §4601, et seq. (40%),
- Evaluations on prior federal and/or state projects (10%), and
- Experience in Williamson County, TN, or the City of Franklin (10%).

More detailed submittal information for Phase 2 (e.g. submittal deadline, maximum page count, minimum font size, etc.) will be provided to the top three (3) ranked firms from Phase 1.

Phase 3 Evaluation (If Necessary)

Based on Phase 2 scoring, the consultant evaluation committee reserves the ability to conduct interviews as the Phase 3 Evaluation. If this Phase 3 Evaluation becomes necessary, the interview score will be averaged with the Phase 2 score to generate a composite score. The scores from both phases will be weighted equally (i.e. 50/50).
