PROJECT DESCRIPTION

This project consists of extension of existing Associates Blvd from LIC Road (Tesla Blvd) to the intersection of Springbrook Road and E. Edison Street. The road will be a two-lane boulevard section with 3 bridges, two existing and one proposed and terminating at a roundabout. The project will also involve constructing of a greenway from Alcoa High School crossing the roadway bridges and a railroad trestle bridge and transitioning to the existing Pistol Creek Greenway.

A Prime Contractor must prequalify with the Department of Transportation in accordance with Section 54-5-117 of the "Tennessee Code Annotated" and Tennessee Department of Transportation Rule 1680-5-3 prequalification of contractors before biddable proposals will be furnished.
