### **PROJECT DESCRIPTION**

The Navy Road Streetscape Phase 2 – This project extends from U.S. 51 to west of Church Street. The project consists of resurfacing the roadway, replacing all driveway aprons and curb ramps to comply with PROWAG standards, and the replacement of the traffic signal at Nelson Road and Navy Road. Construction involves demolition, asphalt pavement, asphalt milling, curb and gutter, sidewalk, curb ramps, driveway aprons, erosion control, traffic control, traffic signals, pavement marking and signing.
