PROJECT DESCRIPTION

This project involves the construction of a 1,546' sidewalk at South Lawrence Elementary School along the northern side of 2nd Avenue South between Collier Street and Riddle Street. The work to be done consists of constructing 1546' of sidewalk, clearing and grubbing, removal of pavement, pavement repair, grading, sodding, installation of curb and gutter, 4' of 4' wide concrete stairs and steel tube handrail, curb ramps with truncated dome surface, crosswalk striping, and drainage improvements. Drainage improvements include installing 580' of 18" concrete pipe culvert with two end walls and two catch basins. The total Project length is 1799'.
