PROJECT DESCRIPTION

This project consists of constructing approximately 0.616 miles of walking/biking trail. The trail will connect Maloney Road Park at the intersection of Maloney Road and Ginn Drive to the UT Farm access drive just south of Maloney Road on SR115 Alcoa Highway and a greenway under construction as part of TDOT's Alcoa Highway Project.
