PROJECT DESCRIPTION

The project involves the construction of approximately 1900 linear feet of asphalt pedestrian trail, 150 linear feet of switchback handicap ramp, concrete sidewalk and two asphalt parking areas. Project includes the installation of two precast restroom facilities with associated utilities and two grinder pump stations. Project also include drainage piping, erosion control, shade sails, benches, trash cans and minor landscaping.
