#### PROJECT DESCRIPTION

This project is located in Mt. Juliet, Wilson County, Tennessee and involves the construction of approximately 3,430 feet of 10-foot wide asphalt trail, 1,434 feet of associated raised boardwalk and an approximately 125-foot pedestrian bridge over Cedar Creek. At the extreme western end of the greenway, connection with Charlie Daniels Park will be provided with boardwalk and asphalt paths, modifying existing trails for the connection. At the extreme eastern end of the greenway an existing gravel parking lot will be paved with asphalt and striped to provide improved access to the greenway. Total project length is approximately 4,832 linear feet.

### PROPOSAL CONTRACTS WILL BE ISSUED UNTIL THE TIME SET FOR OPENING BIDS

A Prime Contractor must prequalify with the Department of Transportation in accordance with Section 54-5-117 of the "Tennessee Code Annotated" and Tennessee Department of Transportation Rule 1680-5-3 prequalification of contractors before biddable proposals will be furnished.
