

# Nolensville Pike / State Route 11 Widening Newsletter

July 2025

## Phase 1 Project Description:

The project widens Nolensville Pike from a two-lane to a five-lane road (including a dedicated turn lane and bike lanes). It stretches from south of Burkitt Road to near SR 254 (Old Hickory Boulevard). The project includes reconstruction and widening for approximately 4.4 miles. The proposed improvements are intended to address congestion, improve safety, and accommodate growth in this rapidly developing area.

Due to the size of improvements to SR 11, TDOT has split this project into two phases. Phase One, from north of Mill Creek to near SR 254 in southern Davidson County, is currently under construction.

#### **Phase One Progress**

#### 1. Completed Work:

- 1. Storm drainage structures placed
- 2. Buried utilities (water, sewer, and gas) installed
- 3. Additional water lines installed
- 4. Holt Road construction:
  - 1. Grading completed
  - 2. Overhead electric and communications relocated

## 1. Active Work:

- 1. Arch culvert work that crosses Nolensville Pike at north end of project
- 2. Setting utility poles and placing overhead electric along the north end of the project (Lenox Village Drive to Old Hickory Boulevard)
- 3. Grading operations from Bradford Hills Drive to Celebration Way
- 4. Water, sewer, and gas installation
- 5. Placing street lighting and signal interconnect on the south end of project
- 6. Phase One storm drainage placement
- 7. Applying topsoil and final stabilization to the slopes at south end of project
- 8. Telecommunication relocations along the new utility poles from the beginning of the project to Lenox Village Drive
- 9. Hole Road construction:
  - 1. Buried utilities installation

### 1. Upcoming Work:

- 1. Phase One storm drainage placement continues
- 2. Water, sewer, and gas installation
- 3. Holt Road construction:
  - 1. Placing curb, base stone, and asphalt paving
  - 2. Reopening Holt Road by end of July
