Summary **PROJECT DESCRIPTION**

Due to the rapid growth experienced and projected for the greater Nashville area, the current I-40/Donelson Pike (S.R. 255) interchange has an inadequate configuration to handle the traffic demands along Donelson Pike adjacent to the Nashville International Airport. The purpose of this project is to relocate and widen Donelson Pike (S.R. 255) and construct a Diverging Diamond Interchange (DDI) to improve the traffic efficiency and safety of the interchange and access to the Nashville International Airport.

A Unique and Innovative Interchange **THE DIVERGING DIAMOND**

BEGIN Project I-40

The Diverging Diamond Interchange (DDI) is relatively new in the United States, but rapidly gaining popularity. TDOT has constructed two DDI's in the state and has seen great success in regards to safety and efficiency. The first DDI for TDOT was the US 129 / W. Bessemer Street Interchange in Alcoa which opened in 2010 and was logged as 5th in the US. The second DDI for TDOT was the I-40 / S.R. 66 (Exit 407) interchange in Sevierville, which serves as the main entrance to the Pigeon Forge, Gatlinburg destinations. The project was opened in 2015 and was logged as the 51st in the US.

The safety and efficiency benefits of Diverging Diamond Interchanges are due to the unique configuration that crosses traffic to the left (opposite) side of the interchange under a signalized intersection to allow free-flow left turns on to and off of the interstate. The signalized intersection for a DDI is simplified because the phases for left turns are removed and only two phases are required (green or red). The free-flow left turns on and off the interstate increases the efficiency of traffic flow and reduces the need for left turn lanes and the amount of conflict points of turning left across traffic (potential for head-on and T-bone collisions).

The left-turning movements that benefit with this interchange are:

- **1** From I-40 Westbound (Mt. Juliet) to Southbound Donelson Pike (*Airport/ Antioch*)
- 2 From I-40 Eastbound (Nashville) to Northbound Donelson PK. (Donelson)
- **3** From Northbound Donelson Pike (Antioch) to I-40 Westbound (Nashville)
- 4 From Southbound Donelson Pike (Donelson) to I-40 Eastbound (Mt. Juliet)
