Nolensville Pike / State Route 11 Widening Newsletter

June 2025

Phase 1 Project Description:

The project widens Nolensville Pike from a two-lane to a five-lane road (including a dedicated turn lane and bike lanes). It stretches from south of Burkitt Road to near SR 254 (Old Hickory Boulevard). The project includes reconstruction and widening for approximately 4.4 miles. The proposed improvements are intended to address congestion, improve safety, and accommodate growth in this rapidly developing area.

Due to the size of improvements to SR 11, TDOT has split this project into two phases. Phase One, from north of Mill Creek to near SR 254 in southern Davidson County, is currently under construction.

Phase One Progress

1. Completed Work:

1. Storm drainage structures placed
 2. Buried utilities (water, sewer, and gas) installed
 3. Utility poles and overhead electric lines are placed along the project from Bluff Road to Lenox Village Drive
 4. Holt Road construction:
 1. Grading completed

1. Active Work:

1. Pouring concrete wall panels for retaining wall five
2. Setting utility poles and placing overhead electric along the north end of the project (Lenox Village Drive to Old Hickory Boulevard)
3. Grading operations throughout the project
4. Water, sewer, and gas installation
5. Placing street lighting and signal interconnect on the south end of project
6. Phase One storm drainage placement
7. Placing topsoil on slopes at south end of project
8. Telecommunication relocations along the new utility poles from the beginning of the project to Lenox Village Drive
9. Hole Road construction:
 1. Storm drainage and buried utilities installation

1. Upcoming Work:

1. Phase One storm drainage placement
2. Water, sewer, and gas installation
3. Holt Road construction:
 1. Placing curb, base stone, and asphalt paving
4. Phase one of the arch culvert that crosses Nolensville Pike to be installed on the north end of the project
