Project Background

The Tennessee Department of Transportation (TDOT) proposes to improve SR-11 (US 31-A), Nolensville Road from south of Burkitt Road to near SR-254 (Old Hickory Blvd), in Metro Nashville-Davidson and Williamson Counties. The proposed improvement includes the reconstruction and widening of an approximate 4.0 mile section of Nolensville Road and is intended to address congestion, improve safety, and accommodate growth in this rapidly developing area. TDOT is currently coordinating with the Federal Highway Administration on the preparation of the environmental documentation for this project.

The existing roadway is primarily two lanes. The proposed improvement will widen the existing roadway to a five-lane highway with sidewalks and gutters. Since the last public meeting on January 9, 2006, the proposed alignment has been shifted slightly to the east and extensive retaining walls have been added in order to mitigate the impacts to properties on both sides of the road in this area.

The Environmental Review Process

The National Environmental Policy Act (NEPA) requires that projects receiving federal funding or requiring federal actions (e.g. permits) undergo an environmental review process. The project cannot proceed until the requirement has been completed. The purpose of the NEPA process is to fulfill NEPA requirements and disclose effects of a project at a stage in the process

where decision making can still be shaped by environmental analysis and by comments of agencies and the public.

- Historic and Archaeological Resources
- Traffic and Safety
- Ecology and Natural Resources
- Hazardous Material Sites
- Environmental Justice Issues
