**This Addendum Application Form is used for an Outdoor Advertising device location with an existing valid control permit.**

 This addendum application is used to request an upgrade of an existing permitted Outdoor Advertising device to a digital/ LED display.

The minimum spacing of the changeable message signs with a digital display facing the same direction of travel on the same side of the interstate system or controlled access highways is two thousand feet (2000'); provided, however, that an outdoor advertising device that uses only a small digital display, not to exceed one hundred square feet (100 sq. ft.) in total area, within a larger non-digital sign face is not subject to the minimum spacing requirement established in this subdivision (b)(3), or to any application for a specific digital display permit or permit addendum as established in subsections (c) and (d), or to any fee for a permit addendum as established in §54-21-104(b). Tenn. Code Ann. § 54-21-119 (b)(3).

**NOTE: Failure to meet any of the following requirements will result in the return of your addendum application to an existing permit without processing.**

- 1) This addendum must be submitted by the permit holder or agent/representative.
- 2) Permit Tag Number must be provided as part of the addendum.
- 3) A check, cashiers check or money order in the amount of **\$70.00** payable to TDOT for the addendum application fee is required. Cash payment will be accepted only by personal delivery at the Outdoor Advertising Office.

**If the addendum is approved to the existing permit, the digital display sign face is subject to the following restrictions:**

- 1) The message display time shall remain static for a minimum of eight (8) seconds with a maximum change time of two (2) seconds;
- 2) Video, continuous scrolling messages and animation are prohibited; and
- 3) The minimum spacing of such changeable message signs with a digital display along an interstate system or a fully controlled access highway is two thousand feet (2,000) for digital displays facing the same direction.

The addendum is not transferable to another Outdoor Advertising Device. I hereby certify that I have personally examined and understand Tennessee Code Annotated § 54-21-101, et seq. and TDOT's Rules for the Control of Outdoor Advertising, Tenn. Comp. R. & Regs. Ch. 1680-06-03-.01 through .09 (2024), and this permit addendum is made in compliance with same. I further certify that the statements made on the addendum are accurate and true to the best of my knowledge and understand that, if investigation reveals that any of the information on the addendum is false, the addendum will be voidable.
