Proposed Fiscal Year 2025-2027 Comprehensive Multimodal Program

I am pleased to present you with the department's Fiscal Year 2025 Comprehensive Three-Year Multimodal Improvement Program in support of our budget. As we have said, Tennessee is at a critical point as we continue to provide vital mobility solutions for Tennesseans. As Tennessee continues to grow and flourish, due to our state's sound and principled leadership, this success brings additional infrastructure needs at a time when resources to address these needs remain flat. Other states when faced with such challenges have chosen to raise taxes, issue debt, or spend a disproportionate amount of funds to address needs in urban communities, while neglecting needs in rural areas. However, in Tennessee, the General Assembly took bold action by passing the Transportation Modernization Act in a bipartisan manner. This legislation makes better use of our resources through innovative contracting tools, leverages investments from the private sector, and invests a landmark \$3.3B in our state's transportation infrastructure network. These actions empowered the department to develop our 10-Year Plan, a fiscally constrained, long-range investment strategy that provides a spending roadmap for \$15B in state and federal funds over the next decade for surface transportation improvements. The 10-Year Plan includes 93 site-specific projects across the state, 46 of which are directly supported by the General Assembly's one-time investment of \$3B in the state highway fund.

The proposed three-year plan serves as a subset of our 10-Year Plan and identifies funding for projects in all 95 counties, addressing important transportation needs in rural, suburban, and urban communities. Specifically, it identifies preliminary engineering, right-of-way acquisition, and construction for 63 major highway projects in 36 counties across the state. One such project is Tennessee's first-ever potential Choice Lane along the I-24 Southeast corridor. This project was approved for further development by the Transportation Modernization Board earlier this year and is included in this three-year plan for construction in Fiscal Year 2027.

As always, the department remains committed to keeping our transportation assets in a good state of repair, and this three-year plan identifies funding for such efforts, including 124 interstate and state route resurfacing and concrete preservation projects, as well as critical rehab projects for 36 on-system bridges throughout the state. In addition to preserving and expanding our transportation and mobility assets, safety continues to be a top priority for the department through identified funding for needed safety improvements across our diverse multimodal transportation system. Finally, transportation for Tennesseans means more than roads and bridges, and this plan includes funding for aviation, transit, rail, and other multimodal infrastructure improvements and expansions.

Committing to the progression and funding of projects through all phases of delivery, including construction, is an important transparency measure and is reflective of a more focused approach to delivering projects in the most expedient manner possible. For TDOT, this renewed focus means what we start, we finish, and this three-year plan demonstrates the department's commitment to that philosophy as we remain on track for the timely delivery of projects identified for development or construction in last year's three-year plan. This commitment is also demonstrated in our on-time delivery of 90.6% of projects budgeted for construction in Fiscal Year 2023. The department will continue to keep members informed of the progress made on projects identified for funding in a previous three-year plan through our quarterly reports to all members. While these quarterly reports have been temporarily modified to allow the department to align the reports with the current 10-Year Plan, the full quarterly reports will resume in quarter two of 2024.

Altogether, this three-year plan represents a fiscally constrained and targeted investment strategy that continues to develop and deliver needed projects across the state in rural, suburban, and urban communities, while responsibly funding our efforts to maintain our assets and address emerging safety needs.
