New Business

Tier II Update – Mr. Michael Rinehart

- i. EPCRA requirement
 - a. The purpose of this form is to provide state, tribal, and local officials, and the public with specific information on potential hazards.
 - b. Deadline Ian 1 March 1
- ii. Tennessee
 - a. 18 counties had a 2-22% increase in Tier II's from the previous year
 - b. 19 counties had a 10-33% decrease in Tier II's from the previous year

Per- and Polyfluoroalkyl (PFAD) Substances - Ms. Emily Leard

- i. PFAS associated health risks & exposure pathways
- ii. Federal Rules & Updates
 - Designation of PFOA and PFOS as CERCLA Hazardous Substances Final Rule -(April 19, 2024)
 - b. Currently under 60-day court stays for new Administration review
 - 1. Maximum Contaminant Levels (MCLs) establishing the First National Drinking Water Standards for 6 PFAS in finished drinking water
 - 2. The designation of PFOA & PFOS compounds as hazardous substances under CERCLA
- iii. Aqueous Film Forming Foam (AFFF)
 - a. FAA Guidance for change out in Mobile Firefighting Systems

- b. DOD Working to address challenges to transitioning to PFAS free alternatives TDEC's PFAS Response
 - a. Completed all initial source water sampling
 - 1. February 2025 verified the results of samples tested
 - b. Response Strategy
 - 1. Information Make data driven decisions
 - 2. Education Bring together education institutions and networks
 - 3. Mitigation Aim to be proactive and preventing further introduction of PFAS into the environment
 - c. Ongoing Efforts
 - 1. Biosolids & Permitting Considering incorporation of testing for PFAS in biosolids
 - 2. Research TDH lab capacity and expanding PFAS testing
 - 3. Funding Anticipated Funding opportunity through EPA

Hazardous Materials Regulations (HMR) - Mr. Michael Rinehart

- i. Final rule is effective on April 3/2024 with Compliance date on March 4/2025
 - a. Flexible packaging option for compressed natural gas
 - b. Aligning the HMR with international standards by establishing clear and consistent rules for transporting very small amounts of poisonous substances
 - c. Defining the required design and construction standards for cylinders intended to store hydrogen mixtures, including pressure ratings, materials, and safety features.
 - d. Requiring specific labeling on cylinders to clearly indicate the presence of hydrogen and its concentration, as well as any relevant safety information.
 - e. Creating marking exception for lithium button cells installed in equipment.

Morristown Hazardous Response Team (HMRT) – Mr. Michael Rinehart

- i. Evaluated for a Type II HazMat Team
 - a. may conduct offensive operations at all HazMat incidents of known and unknown chemical hazards, except which are known or suspected WMD
- ii. Pending Director approval
