# COVID-19 Vaccine Pharmacy Claim Submission

**Effective December 28, 2020**, TennCare began reimbursing pharmacy providers through the OptumRx Pharmacy Point of Sale System for the administration of COVID-19 vaccines.

CoverKids and CoverRx claims also follow this guidance.

The following is a list of covered COVID-19 vaccines that are now eligible for pharmacy administration reimbursement.

At this time, the cost for the vaccine itself will be covered by the federal government via funding authorized by the Coronavirus Aid, Relief and Economic Security (CARES) Act.

An administration fee, *in line with the current Medicare payment rates*, will be paid to pharmacies that submit claims for covered COVID-19 vaccines within the specified product limits.

- Administration fee for two dose vaccine: first dose \$16.94 / second dose \$28.39
- Administration fee for a single dose vaccine: \$28.39

### **Claim Submission**

When submitting a claim for the COVID-19 vaccine, submission should include the NCPDP fields as depicted below and follow recommended guidance.

In accordance with CMS regulations, reimbursement for COVID-19 administration is limited to CMS recognized licensed provider types issuing a patient-specific order.

- If pharmacies have an existing Collaborative Pharmacy Practice Agreement (CPPA) for COVID-19 vaccine with a current provider, they should use that provider on pharmacy claims to TennCare.
- If pharmacies do not have an existing CPPA for COVID-19 or a provider with a Tennessee Medicaid ID is not available, the Tennessee Department of Health has issued a COVID-19 Collaborative Pharmacy Practice Agreement with Dr. Tim Jones (NPI 1245362565) as the authorizing physician. Pharmacies must use the link below to view and execute this agreement. Once this agreement is signed and all requirements are followed, pharmacies can submit claims for approved COVID-19 vaccines with Dr. Jones as the ordering provider.

### **Reminders**

- Claims for COVID vaccines are exempt from co-pays and script limits for all TennCare enrollees
- COVID vaccine claims for dual eligible enrollees (Medicare eligible) will receive NCPDP reject 65 "Patient has Medicare Coverage, Bill Medicare"
- If a claim is submitted for a member's second vaccination dose with an NDC from a different manufacturer used with the first dose, the claim will be denied, requiring prior authorization.
