



**There is a limit on how many children can enroll in Part A and Part B.**

The limits are based on the amount of funding approved for the program. We sometimes call these limits for each Part “slots.” Slots for both Part A and Part B are limited and dependent on available funding.

## How do I apply for Katie Beckett?

To apply for Tennessee's Katie Beckett Program, follow the steps below:

Fill out a self-referral application: [perlss.tennnecare.tn.gov/externalreferral](https://perlss.tennnecare.tn.gov/externalreferral)

Filling out the self-referral online is the fastest way to apply for the program. But if you don't have a computer, a Department of Disability and Aging (DDA) case manager can help you complete the self-referral. To get help, call the DDA office in your region:

- West Tennessee: (866) 372-5709
- Middle Tennessee: (800) 654-4839
- East Tennessee: (888) 531-9876

Once you complete the self-referral, a DDA Case manager will contact you to conduct an assessment. Be ready to provide medical documents that clearly identify your child's condition and/or proof of intellectual disability at the time of the assessment. Please note: your child's enrollment could be denied or delayed if you are unable to provide these supporting documents when we meet.

## What is Katie Beckett?

### The Right Care in the Right Place at the Right Time!

Tennessee's Katie Beckett program is for children under the age of 18 with disabilities or complex medical needs. This program is for children who are not Medicaid eligible because of their parent's income or assets.

This program has three parts, A, B and C, and will provide services and/or help pay for medical care that private insurance does not cover.

**Katie Beckett Part A** is for children who would qualify for care in a medical institution—like a hospital, nursing home or ICF/IID (Intermediate Care Facility for Individuals with Intellectual Disabilities). But they want care at home instead.

**Medicaid Diversion Part B** is for children who don't qualify for care in an institution. But they're "at risk" of going into one unless they can get services.

**Continued Eligibility Part C** is for children who have Medicaid now, but their Medicaid is ending because their parents' income or resources increased. Part C may allow the child to keep Medicaid if they would qualify to enroll in Part A, but there isn't a slot open for the child right now.

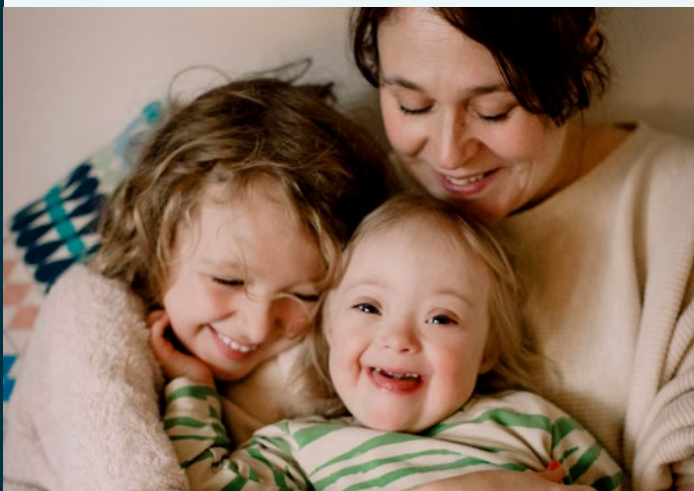
## What services are covered in Katie Beckett?

The services your child can receive in the Katie Beckett Program depend on which part they are enrolled in.

### A few services for Part A and Part B may include:

- Doctor and hospital visits
- In-home nursing services
- Medical equipment and supplies
- Occupational Therapy
- Physical Therapy
- Speech Therapy
- Non-emergency transportation (NEMT)
- Community Integration Support Services
- Community Transportation
- Decision making supports
- Family Caregiver Education and Training

Private insurance must pay first. TennCare will help pay for those things private insurance doesn't cover, **including insurance deductibles and copays.**



## What are the benefit groups for Katie Beckett?

### Katie Beckett Part A

Children in Part A receive full Medicaid Benefits and also can get up to \$15,000 a year in nonmedical services called home and community-based services. A child must have private insurance, and a premium may be required based on the family's income.

### Katie Beckett Part B

Families get up to \$10,000 a year in services to care for their child. Families may use their Part B funds in one or more of the following five ways: a card to pay for medical expenses, paying for a child's private insurance premium, getting paid back for certain services including non-traditional therapies, hiring staff to provide respite and supportive home care, or having a community provider for services.

### Katie Beckett Part C

Children in Part C have Medicaid benefits. Children in Part C are not required to maintain private insurance but may have private insurance (or other third-party payers).

## What is Consumer Direction?

**Consumer Direction** offers more control over who gives your child home care and how the care is given. You hire the people who give some of your home care. They work for you.
