

## TennCare Benefit Packages

The card that you get from your health plan or MCO (Managed Care Organization) may have a letter on the front. The letter is called a **Benefit Indicator**. Check the front of your health plan card. The letter **A - M** will tell you what kind of care TennCare covers for you. It also tells your doctors what kind of care is covered for you.

“Long-term care” is care that is delivered in a nursing facility, including special nursing facilities for people with intellectual and developmental disabilities. Long-term care can also include certain services and supports that are delivered in the home or community.

“CHOICES” is a long-term care program offered by the health plans (MCOs) to people who need nursing facility care or who are at risk of needing nursing facility care. For people who qualify for CHOICES, this care may be provided in a nursing facility or in the home or community.

“Employment and Community First (ECF) CHOICES” is a long-term care program for people who have an intellectual or developmental disability (I/DD).
