

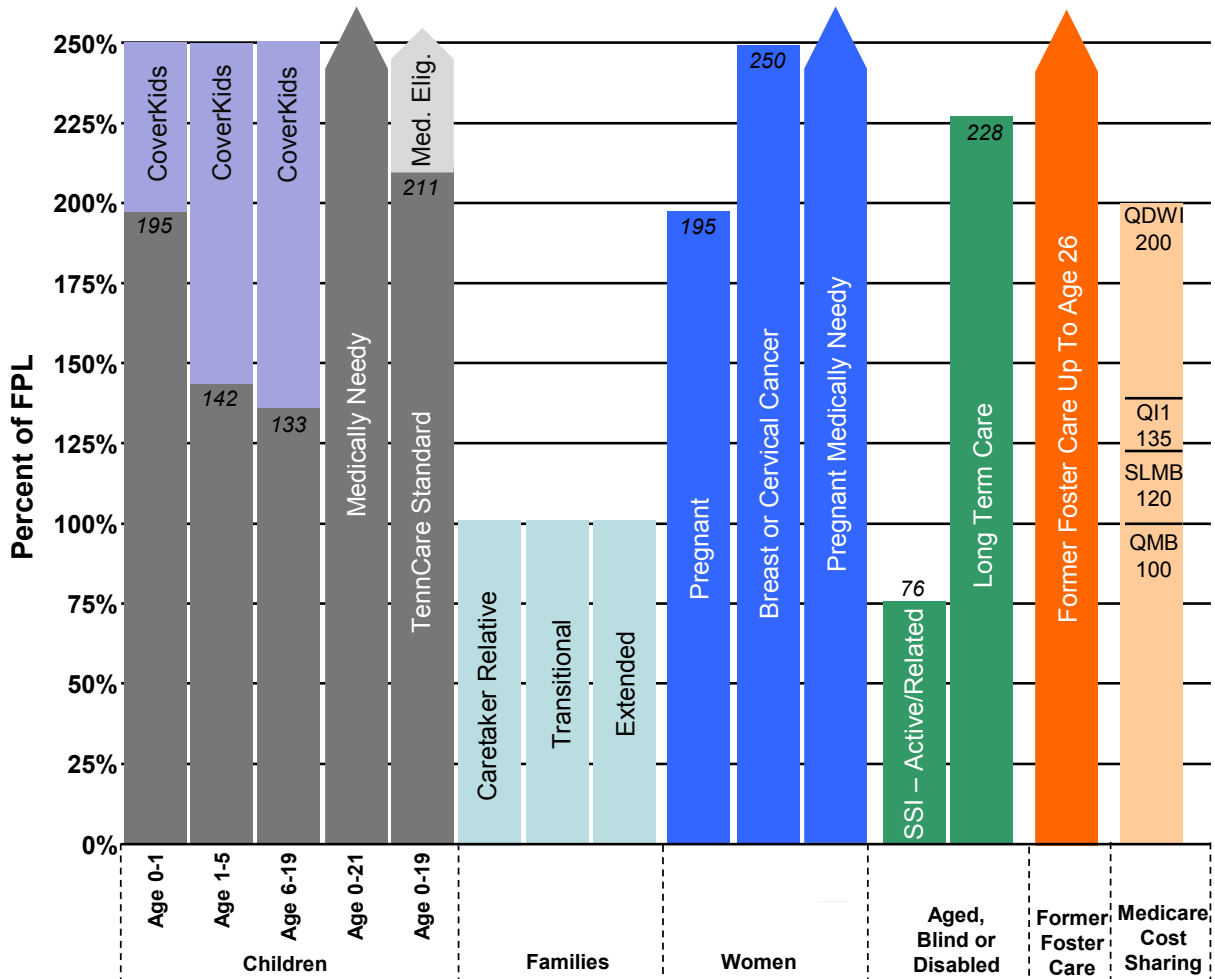
Annual and Monthly Income in Dollars

	Standard Uninsured	Children under age 19 who do not have access to insurance. Category is only open to children who lose Medicaid eligibility and rollover into Standard.	Below 211% of the poverty level No resource test
	Standard Medically Eligible	Children under age 19 who do not have access to insurance and who have health conditions that make the child uninsurable. Category is only open to children who lose Medicaid eligibility and rollover into Standard.	Above 211% of the poverty level
	CoverKids	Available to children under age 19 and to the unborn children of women not eligible under another TennCare category.	Above TennCare income limits and below 250% of the poverty level No resource test
