PCMH- Wave 2 Application and Selection Timeline

Open PCMH application

PCMH applications due back to State

Selection of Wave 2 organizations

Wave 2 organization activities begin

2 month application window

May 1, 2017

- PCMH application will be opened for potential respondents*
- Only 1 application should be submitted per Tax ID

June 30, 2017

- Deadline to submit applications, with State fielding questions as needed

August 1, 2017

- State to review submissions and announce Wave 2 PCMHs to the applicants
- Organizations may begin contracting for PCMH with MCOs

January 1, 2018

- Organizations begin Wave 2 of the TennCare PCMH program
- All Wave 1 organizations continue participation

*Note: Wave 1 PCMH organizations do not need to reapply

Episodes of Care- Annual Feedback Session

Save the Date: May 16, 2017

- The Annual Feedback sessions provide the opportunity for the public to comment on what is working well with each episode's clinical design and where providers would suggest changes for next year.
- **20 episodes of care** (Waves 1 - 4) will be open for public feedback.
- Will take place simultaneously in **six locations** across the state linking clinicians, administrators, payers and other stakeholders by video-conference in **Nashville, Chattanooga, Knoxville, Johnson City, Jackson and Memphis**.

Breast Cancer Episodes Update

The Breast Cancer Medical Oncology and Mastectomy episodes from Wave 5 will be delayed

- The Breast Cancer Medical Oncology and Mastectomy episodes in wave 5 will not be included in the May 2017 preview reports because we are working to incorporate Cancer Registry data.
- The performance period for these two episodes will begin with calendar year 2019, instead of calendar year 2018.
- The Breast Biopsy episode will not be delayed--breast biopsy will be included in the May 2017 reports and will have its first performance period in calendar year 2018.

Waves 3 & 4*	2016	2017	Report will cover episodes ending between January 1, 2016 and December 31, 2016 [Preview Year]. Payments will occur in August 2018
Wave 2	2015	2016	Final interim performance report before the final report with financial accountability in August [Performance Year 2016].
Wave 1	2014	2015	Second interim performance report [Performance Year 2016].
