

# Notice of Application to Extend the TennCare II Demonstration

*Published November 9, 2020*

The Commissioner of the Tennessee Department of Finance & Administration is providing official notification of intent to file an application to extend the TennCare II demonstration. This application will be submitted to the Centers for Medicare & Medicaid Services (CMS).

## **Description**

TennCare is a Medicaid demonstration program that has operated under waivers of certain provisions of federal law since 1994. All Medicaid beneficiaries in Tennessee receive services through the TennCare demonstration. The principle being “demonstrated” by TennCare is that a state can organize its Medicaid program under a single, statewide managed care service delivery system without spending more than the Medicaid program would have spent in the absence of the demonstration program and without compromising quality of care. The TennCare demonstration is one of the longest-lasting and most comprehensive Medicaid managed care programs in the country.

The Centers for Medicare and Medicaid Services (CMS) is the federal agency that oversees TennCare. CMS authorizes TennCare to operate for specific periods of time referred to as “approval periods.” The TennCare demonstration is currently authorized through June 30, 2021. In order for the TennCare demonstration to continue operating past that date, the State of Tennessee intends to request an extension of the TennCare demonstration from CMS. The duration of the extension being requested is July 1, 2021, through June 30, 2031.

## **Waiver and Expenditure Authorities**

The extension application will request continuation of all currently approved waiver and expenditure authorities. In addition, Tennessee intends to request a small number of modifications to the demonstration for the upcoming approval period, most notably to more fully integrate services for persons with disabilities into the state’s larger managed care service delivery system. The state will request that the demonstration’s special terms and conditions be modified to reflect these changes.

## **Expected Impact on Enrollment and Expenditures**

This extension application is not projected to have an impact on TennCare enrollment or expenditures. Under the proposed extension, all Medicaid beneficiaries in Tennessee will continue to receive services through the TennCare demonstration.



## **Hypothesis and Evaluation Parameters**

The state is not proposing any changes to its current evaluation design.

## **Public Notice Process**

The Division of TennCare has taken a variety of steps to ensure that members of the public are aware of the upcoming application to extend the TennCare demonstration and have an opportunity to provide input. These measures include publishing information about the extension application (including a draft of the application itself) for public review on the TennCare website, posting information on various social media, and publishing notices in the newspapers of widest circulation in Tennessee communities with 50,000 or more residents.

## **Public Input Process**

TennCare invites interested members of the public to offer comments regarding the extension application from November 9, 2020, through December 11, 2020.

Once comments received during the public input period have been reviewed and considered, a final draft of the extension application will be prepared. The final application will be submitted to CMS no later than December 31, 2020, and will then be made available on the TennCare website.
