# Care Coordination Tool Admissions, Discharges, and Transfers (ADT) Update

As of 3/16/18, the following amount of hospitals are sending ADT feeds to the State for distribution in the Care Coordination Tool (CCT)

- 65% of hospitals
- 71% of licensed hospital beds
- 18 health systems live
- 102 hospitals live
- 17,642 hospitals beds live


