I've also authored dozens of books in the areas of history, biography, politics, literature, and social criticism.

I know and value the importance of a quality education. It's for this very reason I founded Franklin Classical School. Today, I write in support of American Classical Academy Montgomery's application and appeal to the Commission. The Tennessee Public Charter School Commission was founded to take politics out of the process and to judge an application solely on its merits. As a newly elected School Board member in District 7 for Clarksville-Montgomery County, I did not have the privilege to vote on these charter schools. However, I feel compelled to come forward and speak publicly in light of recent comments from another School Board member who has recently declared in the media that there would be no support from local school leaders.

I am a lifelong resident of Montgomery County, a local pastor who attended CMCSS from Elementary school through graduation and am a parent of three children in the district.

Montgomery County is a rapidly growing area, and our student population is increasing by almost 1,000 students yearly. Last year, I attended a fantastic program, Leadership CMCSS, in which district employees shared a lot of great facts about the district. During a session, it was shared that once the Kirkwood Complex is completed, on the current growth trends we would be at the same overpopulation numbers we had in 2021.

We have portables at schools all across our district as our buildings cannot currently properly house the population of students we currently serve. Though I believe in our community and the district office and their plans for the district, I think we need to be open and creative in our approach to the future to best serve our students and community. Charter Schools could help be part of the solution for public education - providing additional public school choices for students who desire additional options and helping alleviate our building demands and overcrowding issues.

This past year as a parent, I attended almost every school board meeting. I heard firsthand the arguments for and against charter schools in Montgomery County and listened to the results of the CMCSS Charter School Review Committee. I also attended the American Classical Academy Montgomery (ACAM) community meeting, where most in attendance greatly supported charter schools.

As a candidate, I heard from the community about charter schools and the tremendous support for American Classical Academy.

From my observation, those who are against charter schools typically focus on the alleged ideology of the particular school or the fact that less funding goes to our current public schools. However, as the funds follow the student, it is a fact that those students attending a charter school would have a portion of their taxpayer dollars follow their child to the charter school. Having a portion of the funds follow the student would be a potential problem if we were a stagnant or declining district. However, we are not a stagnant or declining district, and adding charter schools as another choice for public schools in our community would help with our student overpopulation problem. It would not affect the district as we will continue to grow each year, and a portion of the funding even remains with the zoned public school even though they no longer have to expend resources to educate that student.

ACAM's total school population after seven years would be around an estimated 700 students. The other denied Charter School, Oxton Academy, will have less than 300 students for their model. We currently grow more than this in a year when you compare both schools' total population combined when they are fully operational.

On ideology, I understand that not everyone likes the classical education model. The good thing is that we have excellent schools in CMCSS for those families that want a more traditional curriculum and public school model, but to deny families the option that would select this model based on perceived biased alone is not a good argument. The families ACAM would serve are those who choose to send their students to the school, and those families would love the choice. It's clear to me they desire this option, and no one is forcing families to send their kids here. It's optional.

For those outraged by the comments from Hillsdale College President Dr. Larry Arnn, let me say I have a great love for our teachers and do not in any way agree with his words. However, ACAM is not Hillsdale. They utilize curriculum from the college, but to the critics who make this parallel let me say that ACAM is no more Hillsdale than CMCSS is APSU - which we have partnerships with, and we recruit teachers. To hold ACAM accountable for the comments of a President of an entity that has no oversight or connection to the school except through curriculum is frivolous and political. It's a red herring meant to distract from the real issues of providing educational choices that best fit individual students' education needs.

I appreciate all the work that went into the Charter School Review Committee and believe a lot of good came from this process. Oxton Academy even stated that this committee helped them amend their packets for the good as they pointed out necessary waivers that would help them in the long run. I believe everyone on the committee is well-meaning, and I appreciate their efforts. However, I think the decision to deny the second amended application didn't have merit.

On ACAM's second denial, the health and safety plans were said not to be sufficient; however, this section remained unchanged and was not brought up the first time around. This denial is unfair to make a criticism and not allow them the ability to speak to it or make changes. Secondly, it is my understanding that state law requires charter schools to have a plan for their location - which they did detail a plan. The location plan did not warrant denial as they met the standards, and securing a site for a school that has not passed approved seems to ask them to put the cart before the horse. I digress, though, as they have recently secured their location.

Lastly, waivers were the final reason ACAM was recommended for denial by the Charter Review Committee. As stated before with Oxton Academy, CMCSS suggested certain waivers they should pursue when evaluating the school. Charter Schools applying for waivers is normal, and the denial hinged on the committee not accepting that sufficient data was proven to demonstrate the capacity of the classical model. In my research, the classical education model is very successful and leads to outstanding student education, so I believe these waivers are warranted.

With Oxton Academy receiving approval from the Charter Committee and denial with a 4-3 split from the School Board and with the comments made on "why" they decided to deny this charter school that night and since in the media - it seems that for most of those who rejected Oxton Academy was for political reasons and would have never approved ACAM.

I speak on behalf of what I believe to be a substantial majority of the community in support of charter schools and school choice. Therefore, I am asking the Tennessee Public Charter School Commission to vote to allow parents the option to send their children to American Classical Academy Montgomery.

I submit these comments today on my behalf and not on behalf of the School Board.

This letter, this plea, comes from a heavy heart and exasperated mind. My name is Jennifer I Parker. I have two special needs sons who could not receive educations in the traditional public-school setting. They simply aren't traditional learners. However, they are exceedingly bright as most children of this nature are. Just because they learn differently than traditional students, they too deserve to receive the best education possible that will meet them at their level of learning. I remember the "no child left behind" mantra that was heroically shouted from the rooftops years ago. It echos in my mind as a broken promise because my oldest son Aidan was left behind...repeatedly by a school system promising never to let that happen. It wasn't just that promise that was broken, it was his spirit, his trust in learning and his belief in himself as a child who had the capability to learn. He assumed it was his fault. That was the real tragedy. He was too young to understand the truth of what was happening. An overcrowded school, a teacher already spread too thin, lacking the ability to reach him on his level, and an organization who simply did not want to deal with him because they already had more than they could handle. I begged in middle school for an IEP for Aidan because he excelled in elementary school with that in place. His needs were met. When he got to middle school, I was told, "let's see how it goes" by the guidance counselor. When tested I was told he was too intelligent for an IEP. With research on my side, I recoiled with the fact that behavior was a main factor in an IEP, but I never got one. Aidan begged for help that never came. Lost, confused and bored Aidan began to act out in class. He became the class clown. For this they wanted to send him to alternative school, and we had services put into our home. I feared actually losing my family. I simply would not let this happen. I withdrew him from CMCSS school system and enrolled him in Academy for Academic Excellence. So much damage had been done by this point, he would barely show his face, he hid behind his hair and a hoodie, would barely say a word and just felt worthless. They had their work cut out for them. They were some improvements, but they didn't have the staff to reach Aidan. We need a charter school that targets at risk students like Aidan who slipped through the cracks and the system failed. He's now 16 and going into the 10th grade. I'm looking for a homeschooling program for him that I can afford which is increasingly difficult because I'm disabled and on a fixed income each month. I had no idea how much education can cost! It can be more than a house payment if you want the best for your child which is no doubt what they deserve and are worth! I've looked into Socratic and classical educations, and they are by far the highest rated. Online they are around \$1000/month. I've seen some schools online as high as \$3900/month. And yes, there are two free options, but they fill up extremely fast and are not available. So right now, I'm left scrambling trying to figure out what I can afford so I don't get into trouble and go to jail for my son not being in school and how to find an educational setting that will renew my son's faith in learning so he can have a happy and productive life. All of this while trying to provide for my family's necessities such as food, clothing and everything they need. If Oxton Academy was here I would be able to enroll him for free and not have to worry about how I'm going to pay a tuition and keep clothes on him and keep him fed. I would

also know that he was being engaged with others like himself that learn differently, and he wouldn't feel like an outsider anymore. That alone would be priceless. In the end I want what every parent wants...to see their child happy and successful. I want to know that one day when I'm gone, he can carry on and have a life that is meaningful and giving back to his community and doing for others because someone did it for him. A school like Oxton isn't just a high school, it's a place where boys become men and learn how to start the rest of their lives. Help me give that to my son. He's been through enough. Help give that to all of the at-risk kids in our community. They stand at a turning point, give them a positive option, they will take it and be better for it! Please vote yes for charter schools. Our kiddos are worth it. Families here in Clarksville, TN deserve to have opportunities other families have without having to relocate so our children can have the education they need.
