To be clear, I do not wish to make a comment in support of Nashville Collegiate Prep High School, so I selected "Metro" in opposition to the former. The property at the intersection of Barnes Rd. and Old Hickory Blvd. was bought and then destroyed without any input from the community or the government. That property had historic structures, old growth trees, beautiful rock formations, and streams. It rests in the center of a partly rural community, along Mill Creek, one of our treasures. It might have been Cane Ridge's equivalent to Radnor Lake, preserving not just history but the wildlife that thrived in those acres. However, with zero input from the community a company, which isn't even in Tennessee (from my understanding, it's a Florida company), razed every tree, then bulldozed and blasted the land beyond recognition. I can see the property from my front porch, and have felt my house rattle time and again with the explosions. The brazenness and lack of care has been, to me and my neighbors, profoundly upsetting. I realize we live in a growing county, and I realize that you can't save every tree. I realize that development happens (and sometimes needs to happen). But it ought to happen responsibly, with a care for the humans whose lives are rooted to the place (and those who will live here many years from now). Could they not have saved some of the old growth trees? Could they not have planned the school to fit within the natural contours of the property without exploding tons of granite? Could they not have provided green space and walkability through the old groves for the benefit of those who live here? Could they not have asked, just once, what we thought? If this charter is denied, the developer will likely sell off the land to another developer who will thoughtlessly build a thoughtless subdivision on the wasteland that they created. I'm not sure what's better--a charter school and the valid traffic and noise/light pollution concerns, or a bland subdivision with no mixed use or means for true community engagement or walkability. There could have been, as I said, a park. There could have been some sort of agricultural use, good for the land and its people. There could have been a small town center (like Leiper's Fork) that would have preserved the quaint feel of Cane Ridge while adding a bit of responsible commerce, a project which would have given Cane Ridge a personality and a shape that would have elevated the lives of the people in the area for a hundred years. I'm opposed to the charter school not because I believe that charter schools are bad, but because the people who bought this property have demonstrated no concern for this community--either the human one or the natural one. Those acres are, guite literally, ruined. The shape of the land is forever changed. The trees were hundreds of years old. The wildlife has been expelled. It's too late for my words to do any good, but I didn't want to miss an opportunity to voice my sadness over the loss of this precious part of our community, at the hands of developers who made these decisions from afar. I will forever regret not trying harder to protect this property.

As a member of the community and a school board member, i support the decision to MNPS to deny this application for the following reasons:

Community Concerns

1. Unrealistic Enrollment Goals: The application contains enrollment projections that are

unrealistic, particularly given the under-enrollment of the existing middle school. This raises

concerns about the school's ability to serve the community effectively.

2. Compliance Issues: There are numerous errors in the application's waivers, making it

questionable whether they will be approved by the Tennessee Department of Education. This

places an undue burden on community resources to correct or oversee these compliance issues.

3. Community Involvement: There has been no community input on the current building of the

school. Requests to meet with NEI from council member were made to try address the concerns

and build good will but the request was denied repeatedly.

Parent Concerns

1. English Learner Policies: The application contains policies and standards related to English

Learners that are not compliant with current guidelines. Parents of English Language Learners

may find that the proposed charter school would not adequately meet their children's needs.

2. Insufficient Funding for Transportation: The application does not allocate sufficient funding for

the transportation of both general students and students with disabilities.

This could put a strain

on families who rely on these services.

3. Transparency in Financial Planning: The applicant's refusal to provide a network financial plan

that outlines the fiscal health of other schools in its network may lead to trust issues among parents.

Academic Concerns

1. RTI2 Mandated Intervention Time: The application does not meet the state-required Response

to Intervention (RTI2) mandated intervention time, raising concerns about the quality of

individualized academic support for students.

2. Staffing for English Language Learners: The school has not allocated appropriate staffing to

serve the needs of English Language Learners, undermining the academic potential of this

important subgroup.

3. Portfolio Performance: The school's academic performance data for existing schools either

matches or underperforms compared to Metro Nashville Public Schools (MNPS). This poses a

question about the school's ability to deliver better academic outcomes.

4. Authorizer Evaluation: The authorizer's evaluation of the current school in the portfolio falls

short in the category for Academic Performance Growth, which raises red flags about the

school's academic credibility.

Other Concerns

1. Inadequate Reporting of Managed Schools: The absence of reporting data for schools managed

by Nobel Education Initiative, the confirmed Charter Management Organization (CMO), raises

questions about transparency and effectiveness.

2. Lack of Latest Audit: The application's failure to include the latest audit poses a risk in

understanding the fiscal responsibility and integrity of the school.

3. Incomplete Professional Development Plans: While the application does include a professional

development plan, it doesn't mitigate other operational and financial shortcomings that impact

the overall quality of the education environment.

In light of these concerns, we strongly urge the Tennessee Public Charter Commission to deny the

appeal application of Nashville Collegiate Public High School. Thank you for your consideration.

I have served on Metro Council, representing District 31 since 2019. The new campus construction site for Nashville Collegiate Prep is in the heart of my Southeast Nashville district. I write to express my disappointment in the leadership involved in planning this new campus. During my time on Council, no major construction project has started without significant community engagement, except for this one. Even though a zoning change was not required, I didn't learn of this project until after the property was already being cleared, and the same can be said for my constituents, who were not happy to say the least. A community meeting to discuss the project would have gone a long way towards building a relationship with neighbors and parents of potential students. Among my constituents are both opponents and supporters of charter schools. Opponents are obviously opposed to this new campus, but many of the supporters of charters are not happy that Nashville Collegiate Prep failed to engage the community. The two concerns I have heard most regarding this project is environmental concerns related to the adjacent Mill Creek and traffic on Old Hickory Blvd on the front of the property. What is being done to protect the creek? Will there be turn lanes and shoulders added to this tiny two-lane road and what will be the impact on the intersection at Barnes Road? These are questions residents have not been able to ask. From my experience having facilitated many development related community meetings, every development in my district has ultimately been improved through community engagement. This project hasn't had that and every effort I made to engage with school leadership to encourage community engagement was ultimately rebuffed. I believe community engagement would have led to far less opposition to this school and would have led them to being seen as more of a willing community partner. When determining this school's future, lack of community engagement and the attitude projected from refusing to engage, should be considered.

I am writing in support of Nashville Collegiate Prep High School. I am a parent of a current Nashville Collegiate Prep Elementary student who is thriving in her current school setting at NCP. I am also a resident of Oak Highlands/Deer Valley Subdivision which will be adjacent to the NCP High School Campus. I, as many of my neighbors in Cane Ridge, have not enjoyed the traffic, blasting, and construction that has occurred at the new school site. However, I realize that this is a temporary inconvenience that will result in so much good for our community. I am also a veteran teacher of 17 years and understand the need for schools like NCP in our community. Unfortunately, the school my daughter is zoned for has a history of very low academic achievement. Recent years' test scores at our zoned school showed only 12 % of students proficient in reading and math. As a teacher, I understand the room and chance for growth in this school and I am sure their teachers and staff work very hard to help their students grow. But as a parent of a high achieving child, this environment is not the best place for my child. This environment will not provide the space for growth for my child. Teachers will need to spend the majority of their time, rightfully so, scaffolding and supporting the lower achieving students to help them to grow closer to proficiency. Where does that leave my child? My child's academic growth should not be hindered because of one particular school's academic intervention needs.

Nashville Collegiate provides the academic opportunity for all students to grow. Their community learning models and committed teaching staff create an environment for students to set personal learning goals and work toward them as needed. Students requiring tiered interventions get that extra small group time, but advanced students get the same times working toward their own advancement. No one is stifled, no one is held back. I have had the opportunity to substitute this year at NCP. I can attest to the teachers and administration's planning and intense dedication to teach their students with rigor and intention. I see high expectations of behaviors and follow through when expectations are not met.

With Nashville Collegiate High School, I am excited that my daughter will be able to continue her education at Nashville Collegiate. She will be able to continue to thrive at her needed pace and keep her educational path steady and moving forward. This will not be possible if she is forced to attend our "zoned" school cluster. School choice is a difficult one. If my daughter could thrive in our zoned school, I would have no issues sending her there. However, that is not the case. NCP offers her and her peers a path that other schools could not. That kind of success is good for our kids, our community, and our city. The data of previous years shows that there is much work to be done at MNPS. Charter schools should not be looked at as an oppositional force. They should be looked at as a partner.

Nashville Collegiate High School will provide more opportunity for our community to contribute positively to Nashville. Better education opportunities equal better citizens. Please don't let bureaucracy and politics play with our children's education. Don't let complaints about traffic hinder a

child's ability to excel or be proficient. No one likes traffic and construction. We all know the infrastructure in Davidson County is horrific. Cane Ridge has dealt with a ridiculous amount of real estate developing in recent years. We have let these developers make millions by over developing our land. I understand people's frustration over that. I have them, too. But our children deserve a place like NCP High School. They are investing in our community's future. I say that's more important than a few extra minutes of traffic or a short time of inconvenience because of construction.

Written Comment

My name is Eve Carney, and I have recently joined the Noble Education Initiative (NEI) team in Tennessee and am accountable for the Tennessee charter schools operated by NEI. Having been at the Tennessee Department of Education for 15 years prior to my joining NEI Tennessee, most recently as Deputy Commissioner and overseeing choice, I have a unique perspective to offer as it relates to charter schools and more specifically, Nashville Collegiate Prep High School (NCPHS).

In the time I have been with NEI, I have observed schools being operated with a student-first mission and vision. More importantly, I have observed the actions and hard work it takes to serve all students well - meeting them where they are and moving them forward.

NCP holds itself to the highest of expectations and refuses to accept the lowering of expectations for students, particularly those who have been historically marginalized. I am in these school buildings and classrooms every day and observe the great things that are transpiring - all to equip students to make their goals and dreams attainable. Of particular note, each student has a personalized mobile learning plan that is used regularly with students, so they have familiarity and ownership over their own learning.

As I reviewed the most recent school-level TVAAS data for NCP, I was both surprised and excited by the data I was seeing. Admittedly, our TVAAS composite was not where we want it to be; however, our English learners, which currently makes up more than 40% of our overall student population at NCP, exceeded the All Students proficiency levels across every grade level in ELA, math, and science. This accomplishment is a testament to doing what is necessary to ensure all students learn and grow. Students need and deserve the choice to continue at NCPHS, especially given the current TVAAS scores of the traditional public high schools in the Antioch community.

Separate, but related, I am seeing similar growth trends in another high school operated by NEI, Knowledge Academy, which earned TVAAS scores of level 3 or higher in four of the five EOC assessments - with two earning level 5.

In my experience visiting and overseeing charter schools across Tennessee, I have yet to see this level of investment, both financial and otherwise, in a community as I am currently seeing with NEI. They are "all in" - committing their resources into providing a K-12 option by constructing a state-of-the-art facility and creating a learning environment that is adaptive and smaller in scale than other public options.

As someone who has committed her professional career to ensure that all students have real access to an excellent education, I fully support the approval of NCPHS as a high-quality, public choice option to families in the Antioch community. All families deserve to have a voice and choice in their

child's education, and the approval of NCPHS provides families this choice option.

Written Comment

I appreciate the Charter Commission's opportunity for written comment on the denial of Nashville Collegiate Prep and in support of MNPS. I write to you as a Nashville resident, Metro Nashville Public Schools (MNPS) parent, District 2 MNPS Board of Education representative and as Chair of the Board of Education.

I represent the district that Nashville Collegiate Prep resides in and, frankly, only hear about the school from constituents or community members when there is a complaint. In fact, I've called the school asking how to forward these concerns to their board as its members are not publicly listed nor known. Yet, the board was so unknown that the school could not help me. I've heard this same response from Metro Councilmembers and members of the community. This is a telling reflection of how uninvolved the school and its leadership are within the community and how they lack personal investment in its requirement to meet the needs of the community.

During Monday's hearing, Nobel Education Initiative (NEI) stated they have reduced their marketing costs. If that is the case, I'd be curious to what their previous cost was, but they would not provide an audit during the application process. I have a hard time believing they have reduced marketing costs because the other time I hear from Nashville Collegiate Prep is via social media ads and mailers that are sent to my home to recruit my children. To further illustrate how Nashville Collegiate Prep is not part of the community and that they've already counted on your votes in their favor, I shared one of the mailers in the hearing. As you may remember, it opens with a demeaning statement about "teachers that actually care" aimed at our school system and our staff. Then, the back is where I learned Nashville Collegiate Prep was opening a high school. I was shocked that not only did I not know about it, neither did MNPS nor the Councilmember who should know due to zoning. Yet, there was a rendering of the school and the bold statement of "NC's upper school campus will be open for the 2024-2025 school year!"

Nashville Collegiate Prep obviously believes the Charter Commission will not thoroughly consider their outcomes or ongoing lack of organization and preparation, because their school will open no matter what. I urge you not to do that. The school does not align with your task of opening needed, high quality educational opportunities. The school does not align with our elected school board's responsibilities, which is why we unanimously denied them, twice.

As you know from the MNPS review team findings, Nashville Collegiate Prep did not meet the standards set for academic, operational, or financial findings. Among the many concerns were mentions of Nashville Collegiate Prep not being able to detail their planned curriculum nor how it aligned with Tennessee's State Standards and that they would not provide their latest financial audit. Along with these basic requirements, they are grossly unprepared for English Language (EL) students which is almost 30% of their population and EL students are many of the neighboring communities which is reflected in our MNPS zoned public schools. Not budgeting for

baseline services like an EL teacher and consistently referring to outdated EL policies shows an incredible lack of commitment to those students and families.

I argue that NEI and Nashville Collegiate Prep's Board, has not effectively proven a desire nor need for their schools. The current performance scores of both of NEI's Nashville Collegiate Prep and Knowledge Academy schools are underwhelming. Considering charter schools are provided a great amount of flexibility and first dibs at per pupil funding with minimal oversight, it is unfathomable that a charter school cannot provide remarkably different results than the surrounding public schools. I expect a strong return on investment (ROI) when considering a charter school's results, work, and engagement. I believe this to be part of my fiduciary responsibilities to taxpayers, along with considering the fiscal impact of any school opening within the school system.

The fiscal impact of fixed costs may not be part of the state rubric, but they are something I am expected to consider in opening or reapproving a charter school within MNPS. Opening Nashville Collegiate Prep, when the seats are unwanted and unneeded, is counter intuitive to my fiduciary responsibilities. I must consider the transfer of per pupil costs to this school and the increased fixed costs that it will oppose on us. Students do not leave their public schools in tidy, classroom sized clusters that allow us to reallocate the supports their per pupil funding provided. Instead, MNPS must make up those fixed costs in staffing, maintenance, transportation, and utilities. These fixed costs are not supported within our state funding, which is already the lowest allocation of all Tennessee school systems. So, we are drowning in them to meet our current responsibilities.

I was specifically mentioned a couple times by Mr. Tom Lee, on behalf of Nashville Collegiate Prep, in his closing arguments this Monday and I need to address those comments. If Mr. Lee wants to argue that only items, subjects, or information found within the rubric should be considered then I hold him to the same expectation. Therefore, I still believe his ongoing and alluding points about Nashville private school growth in the 1970s being because families desired smaller classrooms is out of line. Again, please let me remind you that it is exceptionally well documented that Nashville had a mass of private school growth in the 1970s due to federal desegregation orders and the "cross-town busing" of that time. These private schools were not created in response to a need for smaller classroom sizes, as Mr. Lee claimed and then alluded to as a main reason for Nashville Collegiate Prep's existence.

Mr. Lee also used his comments on private school growth to support his repeated statement that MNPS has not opened a new high school since Cane Ridge High School. MNPS has expanded several of our high schools, including the zoned schools that would be affected by the opening of Nashville Collegiate Prep. Just this school year, we opened James Lawson High School to much fanfare as it is a much-needed replacement for

Hillwood High School's deteriorating campus. Still, he is correct that we have not opened a new high school cluster and that is because of my ongoing point that these additional seats are not needed and that MNPS students are well supported within our current schools and options. MNPS does 10-year capital budget and enrollment projections, well beyond the state's required 6-year projections. Like other urban areas with decreased enrollment, we're seeing families move outside of the city/district to find housing they can afford while a younger, child-free demographic is moving into the area. There was a MNPS zoned middle school recently budgeted for in the Antioch area. MNPS even purchased land for this school just a few years ago, but it has not been opened due to the recent charter growth in the area which has resulted in more seats than students, which is evident in surrounding school enrollment data.

An expansion of Nashville Collegiate Prep is not needed nor wanted in Nashville. Their data shows that they're not innovative nor high quality and MNPS does not need additional seats. I ask the Charter Commission to consider and compare the TVAAS data that will be published this week by TDOE, as part of their findings. Again, thank you for the opportunity to address the commission directly. Please uphold MNPS' decision to deny this charter school and honor our ability and right to locally govern our schools with a focus on the equitable improvement of them.


