



RESOLUTION OF THE TENNESSEE PUBLIC CHARTER SCHOOL COMMISSION
REGARDING AMERICAN CLASSICAL ACADEMY MAURY AMENDED APPLICATION APPEAL

Whereas, pursuant to T.C.A. § 49-13-101 et. seq., American Classical Academy Maury ("ACA Maury") submitted an appeal on the denial of its amended charter school application by the Maury County Public School Board of Education dated August 7, 2023 to the Tennessee Public Charter School Commission ("Commission"), which is charged with serving as an appellate authorizer beginning with the 2020-2021 school year, and;

Whereas, representatives of the sponsor of ACA Maury participated in a public hearing on September 21, 2023 to answer questions of the Commission staff and receive comment from members of the public in the proposed district, and;

Whereas, the Commission's Charter Review Committee, conducted a capacity interview on September 8, 2023, at which time representatives of ACA Maury provided responses to questions from members of the Review Committee, and;

Whereas, the Commission, at a quarterly meeting on October 5, 2023, reviewed, discussed, and considered the full appeal record, review committee report, and Executive Director's recommendation prior to voting on a decision;

Whereas, the Commission, determined the following findings of fact:

1. ACA Maury partially meets standard for academic plan design and capacity
2. ACA Maury partially meets the standard for operations plan and capacity
3. ACA Maury meets/exceeds standard for financial plan and capacity

Therefore, be it resolved by the Tennessee Public Charter School Commission that the amended application for American Classical Academy Maury is denied, pursuant to T.C.A. § 49-13-108(5)(C).

Commissioner Levine moved for approval of the Resolution.
