Written Public Comment:

A lot of people are moving over the crowded classrooms. We need a new Approach with the way we teach our kids. Encompass Community School Mastery based learning is what we need.

Good afternoon, this is Torvis Gardner. With the Parent Advocacy work I do daily, I will give you some insight on why ENCOMPASS should be given a chance to help fight the literacy crisis in Nashville. ("THE IT CITY")

Parents need more options to educate their kid(s). Mnps worry about money being pulled from the traditional zoned schools but many of them are priority schools(bottom 5%) and many others are targeted schools. One Glenciff is even labeled a dropout school. Where parents can "AFFORD" to live should not determine how are kid(s) are educated. With over a billion dollar budget, that increases yearly. Nashville should not have so many schools with below 5% literacy rate and for the schools that got off the list like Amqui, Warner, Alex Green, Cumberland, McMurray and R. Churchwell only have 6% up 12% proficient reading rate. As these schools were removed from the priority status, 8 schools transition to priority status with only 1 being a Charter School. That alone proves we needed ENCOMPASS years ago. We need a new approach and to try different styles of learning cause what we been doing has TN ranked in the bottom half of all 50 states. Just look at the number of kids affected with the 3rd grade retention last summer and are in jeopardy of being retained in the 4th grade. These kids were failed by the system years ago. But why?? Those 3rd grade numbers are used to determine how many prisons to build. Your vote of "YES" to ENCOMPASS will change many kids lives that are in the same path of being failed year after year. Each child learn different, and the mastery based curriculum that will be used at ENCOMPASS will give each child support they need NOW, when they need it not years later. Here are some ways Encompass mastery based learning will attack the literacy crisis in Nashville. 1. Personalized and small group learning. 2. Fluency of foundational skills. 3. Problem-solving projects and hands-in- learning. 4. Social-emotional development. 5. Culturally inclusive teaching and learning. And for the students that need more help, interventions with RTI's that are **research-based interventions that are matched to students and implemented with fidelity and appropriate intensity, frequency, and duration**. You CAN NOT continue this path of traditional zoned public schools are offering, that is INSANE. Special Ed is always topic when it comes to trying to get a new type of school approved. ENCOMPASS has done the research and has a plan for Special Ed, that alone is better than what parents are getting at traditional schools right now. Traditional schools have the same excuse when it comes to Special Ed, IEP's and 504 plans, "we don't have the staff." Our kids are going from school yard to prison yard to grave yards!! Nashville already has the number #1 zip code for school to prison pipeline in the nation 37208. We need MNPS and those who make decisions for our kids, to stop playing politics and focusing on just the money but focus on education with equity so our kids will have a chance to succeed after high school by going to college, learning a trade or starting a business. At least have the skills to read, add/subtract and be able write in order to get a decent job in today's workforce. Mrs. Garry ran a pilot in 2022-23 school year using mastery-base learning. STUDENTS GREW AN AVERAGE OF 1.33 YEARS IN JUST 4.50 MONTHS. ENCOMPASS has done a lot of hard work in the community and results shows that parents are asking for a mastery -based educational option. What's the purpose of having school choice options if MNPS wants to limit your choice to sending your child to their zoned failing schools, where your child(ren) get a bottom 5% education from elementary, to middle and then high school. Example my child is zoned for Tom Joy Elem to Haynes Middle and Maplewood for High School. The decision makers kids go to the best schools and/or private schools so the educational decisions they make do not affect their kids education, like it does for the black, brown and under served communities. We need the decision makers to start caring about ALL KIDS education. We the parents are asking you to vote Yes on ENCOMPASS. Parents need the mastery based choice for our kids education.
