I am asking the State Charter Commission to deny Novus Smart Academy's appeal to open in the Rutherford County School District. As a parent of a student who currently attends Rutherford County Schools, I have several reasons why I want the board to deny the appeal, but I will focus on two.

1. The public school system's funding is based on previous school year enrollment. Rutherford County is one of the fastest-growing school districts in Middle TN. The district is consistently fighting an uphill battle to fund the entire system (50+ schools) with the current funding model. Rutherford County Schools are never funded appropriately because of the growth. Granting access to this charter school will take necessary dollars away from a school system already struggling to provide for its students. The public school system needs this funding for teachers, for support staff, for building maintenance.

2. Our local school board denied this charter school's original application and the decision should stay in the hands of the people who know the needs and concerns of the Rutherford County School system. The main reason for denial was budgetary reasons. Our board knows the difficulty this district is having in supporting our current students. If your commission overrules our school board, the state should fund this charter school and not Rutherford County Schools.

The budgetary issues are currently impacting my child's education and this is why you must not overturn a decision made at the local level. A decision made by those who are trying to ensure Rutherford County Schools remain the best-performing schools in the state. A decision that was made by some board members who are very pro charter schools. My daughter's class sizes are too large for the individual attention every student deserves. The average class used to be 24ish students, now it's 31ish. The air conditioning unit does not work in her wing of their school building. She had to attend school in classrooms that were above 90 degrees this week; a week of record-setting high temperatures. The district has had to cut back on educational programs to help children due to the lack of funding. I could go on and on about the ways our school system is "making do" with its current funding deficit which will only get worse if this charter school is approved.

Again, please deny the Novus Smart Academy's appeal.

While I appreciate the state has made investments into public education, charter schools have an advantage of operating like small private institutions. The question I ask is how a non-profit from Minnesota would be allowed to move into Tennessee and siphon education dollars from our local district into what is essentially a private school. Novus schools have approximately 1,000 k-12 students in their schools or the equivalent of HALF of a Rutherford County high school.

In what scenario does this create equity for MY student who is a senior in Rutherford County school?

Will buses run to this school from all over the county? If not, does this create a situation in which only families whose lifestyle or socio-economic status allow them to participate in this school?

What about sports? If Novus does not have a sport a student is interested in, is the student allowed to participate in a sport at a Murfreesboro school? Would they be able to choose which school they choose as their team?

I have many friends who teach in Middle Tennessee schools. They would seemingly fall into the demographic of those Novus would attract with the exception that they have a deep commitment to public schools and all they stand for and are deeply committed to their own communities.

As a parent to a recent college graduate who attended a state school and now a senior in high school, I suggest a better choice would be to focus on our local schools, remove the drill and test environment which is shown to decrease scores and not improve them, and invest in our larger community, not create segregated publicly funded private education in the state of Tennessee.

Tennessee Public Charter School Commissioners,

I am asking the State Charter Commission to listen to the budget concerns of the Rutherford County school board and deny NOVUS SMART Academy's appeal. I have several concerns with regards to the funding mechanism for charter schools. First, our LEAs are funded based on prior years' student population, while the charter schools are funded based on their projected enrollment for the same school year. This funding inequity causes millions of much needed dollars to be reallocated from the existing school budget to fund the charter schools in advance. I believe this money could be put to better use for the funding of land costs, as we have an urgent need to build three additional school buildings to alleviate overcrowding. Rutherford County schools currently utilize 27 portable classrooms, many of which are at least 25 years old.

Secondly, Rutherford County is one of the fastest-growing counties in the state, averaging 1,000 additional students every year. This again puts additional financial pressure on the school budget. In essence, we are actually running at a two year budget deficit for every new student! Forcing our LEA to reallocate even more money to pay for another charter school would truly be detrimental to the financial health of our county. As one school board member stated regarding where the money was going to come from to purchase land for our new schools if we have to pay for additional charter schools, the answer was to ask the County Commission to fund the land purchase by raising county taxes. In 2023, we incurred a 16% county tax increase and an additional tax increase(s) would not be welcome by our citizens when it is caused by something out of the county's control.

Per the U.S.Census Bureau's latest estimate, Rutherford County has seen its population rise from approximately 262,000 to 361,000 since 2010. Our rapid growing pains are very real. We have been trying to keep up with the additional services needed for roads, fire and police department personnel, buildings and other infrastructure, in addition to building the new schools this population explosion continues to require. Rutherford County is no longer considered to be a rural county but a suburban county. The state legislature has effectively tied the hands of our County Commissioners to generate adequate funding to pay for these additional costs by refusing to pass legislation which would allow the county to implement an impact fee on all new housing and commercial projects. This effectively denies Rutherford County an additional way to generate government revenue. This also has a direct effect on our county school budget every year.

Lastly, I feel very strongly that the Tennessee Board of Education should directly fund all charter schools instead of requiring local school boards to pay for the charter schools up front out of their own budget. This is especially true for any charter schools approved by your commission after being denied approval by the local LEA. It also appears that there is no limit to the number of charter schools one county can support, regardless of which entity gave the approval. Additionally, the fact that a local LEA can not appeal your commission's approval of an appealed charter school application is extremely troubling to me. I firmly believe that there should be additional legislation passed which will place some commonsense guardrails in place for the protection of our local LEAs.

Thank you all for taking the time to consider my comments in support of the Rutherford County Schools. I look forward to attending the public meeting on September 9, 2024.
