STAFFING UPDATES

- LEA functions re-organized between two teams:
 - Finance and operations, led by Melanie Harrell
 - School programs and supports, led by Nate Parker
- New Positions and Staff Members
 - Two new staff members on the School Programs teams to support federal programs and special populations
 - Additional staff for district operations: Student Data Analyst and Grants Coordinator
 - Authorizing team added a Data and Accountability Coordinator position to support
 - New start appeals process
 - Increase teams' capacity for analyzing and reporting accountability data

AUTONOMY AND SCALING

- Staff met over the last six months to discuss scaling oversight and accountability practices to accommodate the growing portfolio
- Maintaining quality while upholding school autonomy was the focus of these discussions
- Topics covered include:
 - Assessments and Accountability
 - Site Visits
 - Quarterly Monitoring
 - Pre-opening Process
 - Reporting Calendar
 - Policy Reviews



AUTONOMY AND SCALING

- From an authorizing standpoint schools can anticipate:
 - The length of site visits determined by school's past performance and when earned, visit will be consolidated to a half day
 - Schools will continue to be monitored quarterly on their organizational performance, but the correspondence will be adjusted to make process more efficient
 - Pre-opening will include differentiated checklists and supports based on existing schools, ASD transition schools, and new start operators without pre-existing school sites.



AUTONOMY AND SCALING

- LEA functions review, while keeping in mind:
 - TDOE Monitoring
 - Licensure and background checks
 - IEP monitoring
 - Subrecipient monitoring
- Updated internal procedures around the reporting calendar, data and assessment
- Overview of updates to monitoring for SY 23-24
 - Risk assessment
 - Title I, Title III, IDEA, Parent/Family Engagement, Fiscal
 - Ability to earn reduced monitoring, where possible
