# SITE VISIT UPDATE

- Site visits completed for all 17 schools in the Commission's portfolio.
- Throughout the school year, site visits provided a thorough performance review by observing school academics and operations firsthand.
- Schools received either a half-day or full-day site visit, as determined by the site visit protocol.
- Following each site visit, schools received a site visit report with feedback on strengths and areas for improvement.
- Site visits confirmed strong performance across all schools.

# PRE-OPENING UPDATES

- Pre-opening activities are progressing, with a focus on meeting all ready to open criteria.
- Spring milestones include timely submissions, facility readiness, staffing, enrollment, and budget preparation.
- Strong participation in best practice trainings and timely reporting submissions demonstrate positive engagement by operators.
- All seven schools are **on track** to open in Fall 2025.



# CHARTER SCHOOL PERFORMANCE UPDATE

- Quarterly monitoring provides ongoing feedback on organizational performance.
- Organizational performance remains strong across the portfolio in key areas, including credentialing, background checks, and special populations.
- Financial performance is monitored in the spring using semi-annual financial statements.
- Schools were notified when the review of financial statements indicated that certain financial indicators may not be met.
- Staff proactively collaborate with operators when preliminary financial indicators are off track to ensure due diligence and a plan for long-term sustainability.

# TCAP ASSESSMENT

- Major changes for SY24-25:
  - Memphis area schools will have materials readdressed directly to the school site.
  - Dynamic Learning Maps (DLM) was extended to cover the entire year
    - Grades 3-8 and 11 ELA and Math Alternate Assessments
    - Schools are required to assess eligible students in Fall and Spring Windows.
  - Grade 3 Retake Window is May 21st – May 30th
    - Proficiency/Non-Proficiency scores will be shared on May 20th at the latest.
