CHARTER AGREEMENT ADDENDUM THE ROCK ACADEMY

This addendum (“Addendum”) entered into as of the ____ day of _____ 2026 by and between The Rock Academy (“Operator”) and the Tennessee Public Charter School Commission (“Authorizer”), collectively referred to as the “Parties” for the operation of The Rock Academy (hereinafter referred to as the “Charter School”), both of whom agree to be bound by this Addendum and the Charter Agreement (TPCSC Contract #0026).

Addendum Conditions. This Addendum is by and between the Parties with regard to Section 1.5. Location of TPCSC Contract #0026. This addendum shall temporarily amend the TPCSC Contract #0026 titled “Charter Agreement” entered into as of February 2, 2026, and will supplement the Charter Agreement. This is the first amendment to the original Agreement. Through this Addendum, the Parties wish to incorporate the below amended language:

1.5. Location. The Charter School location is to be determined and shall be located at 5326 Hickory Hollow Parkway in the southeast region of Nashville, TN. If the Charter School proposes to change its location, such change shall not require an amendment to this Agreement unless the location change is materially different from the location of the Charter School as named in this Addendum. Non-material changes in location shall require at least thirty (30) days prior notice to the Authorizer. Any change in location that is determined by the Authorizer to be materially different from the Charter School’s Application location shall require an amendment as set forth in Section 10 of TPCSC Contract #0026. If the Charter School is located at a site owned or controlled by the geographic local education agency (LEA) in which the Charter School is located or a site owned or controlled by the local government where the Charter School is located, the use of such site shall be subject to and governed by a Facilities Agreement between the parties.

This Addendum shall be effective immediately following signature by the Governing Board of the Charter School and the Authorizer. The Agreement shall expire on June 30, 2028, being the second (2nd) year after the date of opening of the Charter School for instruction, unless earlier terminated or renewed pursuant to the terms of this Addendum or state law.
