

## 1038- Title I Supplement Not Supplant Methodology

The Tennessee Public Charter School Commission was established as an independent state entity, serving as the LEA for any public charter school it authorizes. Allocations provided to each charter school are based on one hundred percent (100%) of state and local funds received by the LEA.

## Methodology

The Tennessee Public Charter School Commission passes through all state and local funds, less a 3% authorizer fee, to each charter school in accordance with Tennessee Code Annotated 49-13-112, the procedures developed by the Department of Education, and State Board rule. Each charter school receives their applicable state and local funding allocation, regardless of whether they are Title I – A served.
