Project description as proposed in initial application:

White County will improve river access and create a day-use picnic area at the Mitchell Ford River Access on the Caney Fork River, with an approximate location of Latitude 35.824477, Longitude -85.393934. This will include adding a safe kayak drop point and staging area for equipment setup and easier boat put-in, a pavilion and picnic area for day use, and signage on nearby county and state roads to direct visitors to this river access point and picnic area. Total project cost is estimated to be \$85,000; White County will provide a minimum of 10% of funds for the total project cost.

White County believes that increasing and improving public river access will generate more tourism traffic and revenue, as visitors are increasingly interested in opportunities for kayaking, canoeing, and other water recreation. The county is already known for world-class kayaking opportunities and numerous scenic natural areas. Adding a picnic area and improving river access at this point, which is the start of a popular 5.5-mile paddle trip, will attract more visitors and encourage longer stays in the county.

Project description as completed (or activities within the last year of the contract) and an explanation for why changes were made and when they were approved by TNECD: White County has been soliciting price quotes on the first portion of the project (pavilion/shelter) in order to estimate costs and move forward with the bid process for this part of the project.

Goals of the project and how those have been or are being met: Goals of the project include improving an access point to the Caney Fork River, adding a day-use picnic area at the site, and adding signage to direct visitors to this location, all of which work toward the ultimate goal of drawing more visitors to White County and encouraging longer stays by tourists in the county.

Successes of the project: N/A - this project is still in the planning/pre-bid phase.

Setbacks to the project: N/A

Proposed outcomes/metrics that have been met, will be met, or have not been met and how those will be tracked in the future: This project is expected to increase the number of visitors to the Mitchell Ford River Access area, as well as contribute to increasing overall tourism revenue in the county. Visitors to the river access can be tracked by adding a guest registry at the site when it is complete. Tourism revenue can be tracked in the future by measuring tourism expenditures, state sales tax, and local sales tax. The county will also track sales of Jackson Kayak products.

Project description as proposed in initial application:

These updates are much needed amenities at the town's most visited park. South Carter Street Park sits right on the Calfkilker River and is a beautiful feature in downtown Sparta. White County is already a hub of outdoor recreation in the Upper Cumberland and is home to one of the world's leading manufacturers of kayaks, Jackson Kayak. The kayak access point on the Calfkilker is expected to draw many additional tourists. Kayakers will now have the opportunity to enjoy kayaking in downtown Sparta near many local restaurants and shops. By installing lighting on the pedestrian bridge and walking trail, it will not only make it safer, it will also make it more aesthetically pleasing. The lights will be viewable from Bockman Way, the main thoroughfare in Sparta, and it is anticipated that tourists going through the town will see the lights and be encouraged to stay and visit the park. Once at the park, tourists can enjoy a wonderful walking trail, playground equipment, and the Calfkilker River. By constructing an ADA compliant restroom facility at the south end of the park, the City of Sparta will be able to offer a better experience for all visitors at the park. People will be able to stay longer, enjoy the entirety of the walking trail, and mothers will not have to worry about having to take their children home sooner. This restroom facility will make it easier for other groups of people to enjoy the park as well, such as the elderly community that may be visiting Sparta. The south end of South Carter Street Parks offers a one and half mile walking trail through a beautiful forested area following the river. The City of Sparta is planning an extension of this walking trail in the next few years to continue to offer residents and tourists a wonderful place to recreate.

Project description as proposed in initial application:

The City of Collinwood proposed to improve the Collinwood RV Park in order to attract more tourists, especially Natchez Trace travelers, to the community. Proposed improvements included concrete pads, new utility connections, picnic tables, and fencing.

Project description as completed (or activities within the last year of the contract) and an explanation for why changes were made and when they were approved by TNECD:

The proposed project was completed with the addition of landscaping. Since the concrete was not as costly as anticipated, grant funds were used to landscape along the perimeter of the RV park. This addition was approved by the TN Department of Tourism on 5/1/20.

Goals of the project and how those have been or are being met:

The goal of the project was to entice more visitors to the City of Collinwood. The Wayne County Welcome Center draws hundreds of tourists each year from the Natchez Trace Parkway. Hopefully, many of these tourists will utilize the Collinwood RV park and extend their trip to Collinwood. Additionally, Collinwood hosts many sports tournaments. Many of the tournament visitors will now be able to stay in Collinwood rather than lodging in nearby towns. The project was only recently completed but there has already been several visitors to the RV park. Hopefully, travel will increase once COVID-19 occurrences are reduced.

Successes of the project:	The project was implemented within budget and included landscaping around the perimeter of the RV Park. There have already been several visitors to the park even though it has only recently been completed.
Setbacks to the project:	COVID-19 has reduced travel along the Natchez Trace Parkway and several sports tournaments will not take place in Collinwood this year. Hopefully, once a treatment for the coronavirus is secured, travel and tourism will increase.
Proposed outcomes/metrics that have been met, will be met, or have not been met and how those will be tracked in the future:	The outcomes/metrics will be tracked by the number of RV Park reservations. All RV Park users are required to register with the City of Collinwood. City officials will compare past years' reservations to current and future reservations. Additionally, city officials will compare sales tax revenue.

Project description as proposed in initial application: The City of Clifton proposed to use grant funds to purchase equipment for Clifton's constructed Riverfront Park Stage, previously funded by the Tourism Enhancement Grant. The goal was to create a multi-use facility that provided a place for performances and festivals in the City.

Activities

Project description as proposed in initial application:

The proposed project was to install stage lighting and improve acoustics at the Princess Theatre located at 215 S. Cedar Avenue. The venue is a multi-purpose theatre in downtown South Pittsburg and is the only theatre in Marion County and the entire Sequatchie Valley. The acoustics and lighting was woefully inadequate and both performers and audiences had an inferior experience. With a fully booked 2019 calendar year schedule, enhancement of the sound and lighting systems was desperately needed. Without these basic functions working adequately, visitors and performers would neither come nor return.

Project description as completed (or activities within the last year of the contract) and an explanation for why changes were made and when they were approved by TNECD:

The need was to light not only the stage but other places inside the theatre. The entry into the auditorium was a dark tunnel due to the balcony overhead blocking out the low house lights. Without aisle lights, it was very difficult and perilous to transition from the fully lighted lobby to the darkness of this space. The new stage lighting includes spot lights and color spots/ images that wash and illuminate the stage as well as the performers. This grant enabled tweaking/ improving the existing acoustic installation which now is much improved.

One addition/ chance to the scope of work was the installation of exterior up lights to wash the front facade of the building-a visible opportunity to showcase the theatre as the economic engine to arts and culture in the region. This lighting enhances the Art Deco marquee and overall theatre experience.

Goals of the project and how those have been or are being met:

The goal was to enhance the visitor and performer experience at the Princess Theatre as well as to cultivate and grow its programming. Great shows and performers attract more people and from the beginning, our goal was to cast a wider net than having only local talent. With a very limited marketing budget, The Princess is marketed far and wide and the 2019 schedule was fully booked. There were a number of sold out shows - capacity 347.

Successes of the project:

It has been thrilling to see: the community come together, the number of visitors from out-of-town and the quality of performers that want to come/ have come and routinely expressed their appreciate for this intimate, well-functioning theatre in a small town.

With on-line ticket sales, we have captured audience information and we are aware that The Princess Theatre was on its way to becoming a destination venue. While the local community was engaged, the audience consisted mostly of visitors from out-of town within a 10-30 mile radius.

Setbacks to the project:

There were no setbacks or problems encountered. The installations went well.

Proposed outcomes/metrics that have been met, will be met, or have not been met and how those will be tracked in the future:

The proposed outcomes were met as evident by the well-attended shows, the distance from which patrons traveled, and the feedback of the artist performers. Continue tracking was on these same points: artist's booking; audience attendance; and distance that visitors traveled to attend performances in South Pittsburg. 2019 was effectively meeting these metrics, and 2020 line-up was strong with diverse shows and performers. The Covid-19 shut down interrupted our momentum, so not able to show the increase in participation in revenue as anticipated for the last 6 months.

Project description as proposed in initial application:

Lewis County proposes to use the Tourism Enhancement Grant funds to work with TDOT to provide an important Buffalo River access point, install county-wide wayfinding signage, and launch a local Outfitter entrepreneur to serve Lewis County for a water trail or Blueway on the Buffalo River. The Buffalo River runs through Lawrence, Lewis, Wayne, Perry and Humphreys counties in southern Middle Tennessee. The 125 miles of the Buffalo River is one of the longest un-impounded in Middle Tennessee and contains some of the most scenic and natural paddling and fishing opportunities in the state. Most of the land along the river is privately owned and the other land is Tennessee Wildlife Resources Agency or Tennessee Department of Transportation or County right of way. Starting in March of every year the Buffalo River welcomes canoes and kayaks by the dozens in adjoining Wayne and Perry counties. Lewis County will be positioned to meet the demand of paddlers and fishing enthusiasts by creating new access points and outfitter services to meet demand in this distressed county if awarded grant funding for this project.

This proposed Tourism Enhancement Grant project will focus on Phase One of the Lewis County segment of the Buffalo River Blueway that will include drop off at Metal Ford on the Natchez Trace Parkway and end with parking and take out at Hwy 99 Oak Grove Bridge at the mouth of Grinders Creek. Recreationalist will be able to park at the Hwy 99 TDOT designated Park and Float area through approval created through this project. The address for the Hwy 99 Oak Grove Bridge is 2581 Buffalo Rd. (The intersection of Highway 99 and Napier Lake Road at the mouth of Grinders Creek.)The Hohenwald-Lewis County Chamber of Commerce in conjunction with the Lewis County Government will support the creation of a new entrepreneurial outfitter to ferry kayaks to the Metal Ford Access Point to the Grinders Creek/Oak Grove Access Point for this phase of the Buffalo River Blueway project in Lewis County. County officials plan to work with TDOT to request additional Park and Float access for future sites and obtain county property or leases for designated sites down river to build upon Phase One of the project.

The total cost of the project will be \$61,000. Grant Funds requested is \$53,200. The amount and source of matching funds will be \$2,800 from the Lewis County Government. Additional project funds will be \$5,000 from the Hohenwald-Lewis County Chamber of Commerce.

Project description as completed (or activities within the last year of the contract) and an explanation for why changes were made and when they were approved by TNECD:

Consultant hired to produce a wayfinding signage plan and create the wayfinding signage design. The signage was produced by another contractor. The county road crew installed the signage.

The River Access Point with TDOT has not been completed at this time. Lewis County is still working with TDOT about the River Access Point.

The grant funds only covered wayfinding signage and work with TDOT.

Goals of the project and how those have been or are being met:

Goals

- Link existing public access points and develop new ones
- Create unified branding for the blueway through maps, guides and standardized signs

The public access points are being linked and working toward having new ones in the future.

There is a unified branding for the blueway. Maps and signs have been created and are being used.

Installation of the wayfinding signage and the branding created.

Created new interest in access points to the Blue way.

Finding bidders for the production of the signage. In the end we found a production contractor that was able to do the job.

Project description as proposed in initial application:

A replica of the Eiffel Tower stands in the City of Paris Eiffel Tower Park. This park includes the Eiffel Tower as the center point of the park with playground, walking trail, two tennis courts, Olympic size swimming pool with three water slides, soccer/flag football fields, disc golf, volleyball court, trout pond, concessions and four restrooms. At the time of application a \$1.5 million Splash Pad was proposed and since the time of application has opened to the public. Many visitors drive into Paris as they are passing through Tennessee for the sole reason of taking photographs in front of the tower. We feel that most of these visitors just pass through our community and are not aware of what we have to offer other than visiting the Eiffel Tower. As a part of an Eiffel Tower Park Master Plan we are proposing to enhance the existing site and provide measures to encourage visitors to prolong their stay around the tower as well as in our community.

Our plan was to increase tourism through the availability of a stage and upgraded electricity and accessibility. General enhancements to this site provide a needed venue for festivals and events that will draw both locally and regionally to this location. Most of our successful events and festivals are held downtown. Our City needed an area that can support larger crowds than the court square can presently.

The Chamber invested in and produced promotional videos that cover the many things offered in this community. The Eiffel Tower is featured in these videos. A QR code will be placed in the park and will be present on the interpretive signage. This signage will consist of approximately 50% history about the tower and Paris, with the other 50% geared toward marketing which will drive visitors to the website then ultimately to venues and events around the community.

Project description as completed (or activities within the last year of the contract) and an explanation for why changes were made and when they were approved by TNECD:

After using the stage briefly before COVID forced us to cease activities we realized we very much needed additional trash receptacles and though most performers had their own sound system there were times we needed our own. In summary, the only changes in the project were to add trash receptacles and a sound system for the stage. These were approved by TNECD near the end of the project.

We also came in considerably under budget on the interpretive signage we had proposed. After finding a photograph of a different type of sign used in Washington state we worked with our local sign company. They designed and built a sign that provided the information originally intended with a design we preferred over the type you would usually find in a park. This signage came in much lower than originally budgeted. Additionally, the sign faces were designed so that they can easily be replaced if the information changes.

Goals of the project and how those have been or are being met: The original goals of the project were:

- Increase tourism by providing information about other sites and amenities in the community when people visit the Eiffel Tower
- Provide a venue for music, art and activities outside the downtown area
- Make the Eiffel Tower and the new additions handicapped assessable

The new signage with the QR Code provides a link to the Chamber's website that will provide visitors with information on where to eat, lodging, and other sites to visit in the area.

We now schedule concerts in the park on a regular basis throughout the summer, spring and fall. With the added splash park we are attracting visitors throughout the region to attend the shows. The big attraction of the tower that pulls people into Paris when travelling through the area allows our visitors to take better photos of themselves and their groups in front of the Eiffel Tower.

Before the improvements people were forced to stand in the grass (or mud depending on the weather) to take photos. This made it impossible for anyone with special needs to approach the venue, it is now totally handicapped assessable.

Our goals have definitely been met through new activities, programs and opportunities to utilize the Stage. This month, June, 2021, we will be using the stage for one of the performances in our second Tennessee River Jam that spans over three days with numerous musical acts from Thursday through Saturday.

With the added signage we feel that we are now providing visitors with information, previously we had no way to communicate with them.

Successes of the project:

First and foremost we have the opportunity to capitalize on the already existing Eiffel Tower. We now have the ability to offer other sites to visit within the community as well as restaurants, lodging, etc.

We have the ability to feature local and regional talent in our park on a regular basis. Food trucks have already seen great success during our events.

In addition to meeting our intended goals, during the construction of the Eiffel Tower Splash Park and the Eiffel Tower Improvements, we successfully submitted an application to Blue Cross Blue Shield of Tennessee to construct a \$650,000 play area in Eiffel Tower Park. This facility is opening this week. We truly feel that the latest Eiffel Tower improvements had a big impact on our location being selected by BCBS.

With the partnerships from various departments within the State of Tennessee our Eiffel Tower Park is quickly becoming one of the largest draws in northwest Tennessee.

Setbacks to the project:

: Other than the occasional weather delays, we really did not encounter any setbacks. This project was one of the easiest and most impactful we have embarked upon in some time.

The only negative, not a setback, was as we were beginning to really utilize the improvements, COVID shut us down. However, we scheduled a summer kick off with music and giveaways on Memorial Day weekend this year. We are already seeing record numbers visit Eiffel Tower Park this season. We are excited to see the continued impact on our community as the year progresses.

Proposed outcomes/metrics that have been met, will be met, or have not been met and how those will be tracked in the future:

We will continue to track the numbers visiting Eiffel Tower Park through our partnership with our Chamber of Commerce and heat mapping technology.

As mentioned before with the pandemic, we have been unable so far to really track the true success of the recent improvements. However, as stated before, we know that we are already seeing record numbers visiting the park so far this year.

The City of Bolivar purchased 122-acre parcel of land that is known as Sand Beach Lake, within the city limits of Bolivar. The request was for entrance sign, informational panel board, restroom facility and "Trail of Tears" historical marker. This project is part of Bolivar's long term Master Plan to promote outdoor recreational activity that includes fishing, canoeing, kayaking and paddle boarding that promotes outdoor physical fitness that incorporates a mix of low impact and active recreational opportunities for locals and tourists. In addition to allow for festivals and special events.

Project description as completed (or activities within the last year of the contract) and an explanation for why changes were made and when they were approved by TNECD:

The entrance sign was designed, ordered and installed along with landscaping. The landscaping boosts signage visibility and is a public invitation to the park. The historical marker for the "Trail of Tears" was written and sent to SHPO for board approval. After approval the sign was order, delivered within about 10 weeks and installed by TDOT at the entrance at 575 E. Market St./State Route 15/64. With the extensive high cost of signage, historical marker and the landscape the remaining balance would not have included the informational panel board for the "Trail of Tears".

Other work was completed by the city that included building entrances, driveways and a very large parking lot. Electrical was installed along with water/sewer for the future development of the park.

Goals of the project and how those have been or are being met:

The goals of this project have been met to provide an outstanding entrance to the park, promote community health and fitness by working with partners to hold monthly outdoor walking/running events and festivals and events. The Red White and Bolivar, 4th of July festival brought in approximately 2,300 people from Hardeman County and neighboring counties. People from various counties have visited to go fishing, canoeing and paddle boarding. Many have visited for visual arts photography and painting due to the abundance of natural beauty and wildlife.

Successes of the project:

This is a major goal for the City of Bolivar to bring residents and visitors from across west Tennessee and surrounding states. The area is a beautiful 122-acre park open to the public and available to hold various music festivals, fishing rodeos, walking/running events and for the recognition of the "Trail of Tears".

Setbacks to the project:

The setbacks were from the Covid-19 pandemic, due to the reduction in workforce on a daily basis within all departments, business closures, social distance demands, and many illnesses.

Another setback was from the inflation rate increase of 5.8%, as this being the highest since 1981. Upon the application these costs were not considered and the city was unable to complete all aspects of the proposed project.

Proposed outcomes/metrics that have been met, will be met, or have not been met and how those will be tracked in the future:

The completion of the entrance sign, landscape and historical marker, makes for a very nice entrance and invitation to the park.

Future development is still in the works. The city is aimed toward putting in an eco-counter for the entrance and/or the walking trail to get frequent counts of public visitation and activity.

Other work completed was the entrance driveway, walking trail, sand beach volley ball, electrical and water/sewer for future development of the park.

Project description as proposed in initial application:

White County will improve river access and create a day-use picnic area at the Mitchell Ford River Access on the Caney Fork River, with an approximate location of Latitude 35.824477, Longitude -85.393934. This will include adding a safe kayak drop point and staging area for equipment setup and easier boat put-in, a pavilion and picnic area for day use, and signage on nearby county and state roads to direct visitors to this river access point and picnic area. Total project cost is estimated to be \$85,000; White County will provide a minimum of 10% of funds for the total project cost. White County believes that increasing and improving public river access will generate more tourism traffic and revenue, as visitors are increasingly interested in opportunities for kayaking, canoeing, and other water recreation. The county is already known for world-class kayaking opportunities and numerous scenic natural areas. Adding a picnic area and improving river access at this point, which is the start of a popular 5.5-mile paddle trip, will attract more visitors and encourage longer stays in the county.

Project description as completed (or activities within the last year of the contract) and an explanation for why changes were made and when they were approved by TNECD:

All purchases were made and activities carried out per the application although an extension was required due to the labor and materials shortage due to COVID-19.

Goals of the project and how those have been or are being met:

This project sought to further increase river access-and thus, tourism numbers-by improving river access at a recently created public access point and adding facilities for a picnic area. The county and Chamber of Commerce get frequent requests to add more river access points and improve accessibility to the river. Multiple access points in the area create a more attractive tourism package for kayakers, as they can stay for a weekend and do multiple paddling trips. This goal was met by the successful implementation of the access point.

Successes of the project:

The project was completed within the budget and the citizens and leadership of White County are pleased with the measurable successes of the project.

Setbacks to the project:

An extension was required to complete the project as described; however, within that time frame the project goals were met and the project's implementation was successful.

Proposed outcomes/metrics that have been met, will be met, or have not been met and how those will be tracked in the future:

Drawing visitors, including kayakers, canoers, and fishermen, to White County's rivers has increased local sales tax revenue and likely boost local business revenue. In 2017, White County saw \$22.18 million in tourism expenditures, \$1.36 million in state sales tax receipts, and \$1.05 million in local sales tax receipts. In 2018, the TN Dept. of Tourist Development reported that White County was in the top ten counties for tourism impact increases in the state. The county attributes most of this growth to the increasing popularity of kayaking and other outdoor recreation and the county's reputation as a kayaking destination. Further improving river accessibility and enhancing the day-use area at the Mitchell Ford River Access will increase visitors to the area, many of whom will spend money in the county buying gas and other supplies, as well as many who will likely visit downtown Sparta and its restaurants shops, and breweries. While the tax revenues for the previous fiscal year have not been released yet, they will be a good determination of the project's progress. The other output is the asset created by the day-use picnic area.

Successes of the project: It's been a great success, and has accomplished everything it was meant to!

Setbacks to the project: There were design setbacks, timeline setbacks (waiting for permits), installation setbacks (waiting on a contractor). BUT, it's finally installed, and quite amazing!
