This form should not be used by Multi-Candidate Political Campaign Committees or Single Candidate Committees. No funds may be received or expended for a future election and/or referendum until a political treasurer has been appointed. A new form must be filed if any change to the appointment of a treasurer occurs.

Single-Measure Committees supporting or opposing any referendum must file this form with the Registry of Election Finance at the address above. All campaign financial disclosure reports must also be filed with the Registry in paper or .PDF format.
