Eligibility Requirements

Type 168 - Resident Annual Hunting & Fishing Disabled Under 18

In accordance TCA 70-2-104 (e)(2 & 3), applicants who are under eighteen (18) years of age and who are disabled may receive an annual combination hunting and fishing license. Being "disabled" means the inability to engage in any substantial gainful activity by reason of any medically determinable physical or mental impairment. This means that the condition must be both totally and permanently disabling. A certificate from a physician licensed to practice medicine in Tennessee certifying that the applicant meets the requirements of this subsection is required.

Type 169 - Resident Hunting & Fishing Intellect Disabled

In accordance with TCA 70-2-104 (a)(3A), Persons with intellectual disabilities" means persons who possess an intellectual disability, as defined by § 33-1-101 and who are over ten (10) years of age. A certificate from a physician licensed to practice medicine in Tennessee certifying that the applicant meets the requirements of this section with reference to such disability is required. The person must be accompanied by an adult at least twenty-five (25) years of age or older, who is hunter-education-certified and licensed to hunt. The person shall be required to complete the hunter education course as provided in § 70-2-108 in the presence of a licensed adult, but shall not be required to attain a particular score on the course examination or take the course more than once.

Type 189 - Resident Hunting & Fishing Wheelchair Restricted Citizens License

In accordance with TCA 70-2-104 (a)(4A), applicants who are permanently restricted to wheelchairs or who have suffered an amputation of seventy-five percent (75%) or more of a lower limb. A certificate from a physician licensed to practice medicine in Tennessee certifying that the applicant meets the requirements of this section is required.

Furthermore, I agree to surrender this license should I become ineligible under the provisions above.

Type 190 - Sport Fishing Slat Basket Tag

Name of reservoir or stream where you plan to fish:

Only one tag will be issued annually per individual. **The tag must be securely fastened to the basket.**

Slat baskets may have only one outside funnel opening and may be made of wood, plastic, or cane slats or splits which are placed lengthwise and so constructed that there must be a minimum of four openings in the catching area, each being at least 1-1/2 inches wide and 6 inches long.

Waters open: All public streams and reservoirs.

Fish which may be taken: Non-game fish.

Creel Limit: Same as sport fishing.

Type 197 - Resident Fishing License for the Blind

In accordance with TCA 70-2-104 (a)(1) applicants who are certified to be blind, having a visual acuity, with maximum correction, not exceeding 20/200 in the better eye or having a visual acuity exceeding 20/200 but accompanied by a limitation in the field of vision such that the widest diameter of the visual field subtends an angle no greater than twenty degrees (20°). A certificate from the department of human services or from a physician licensed to practice medicine in Tennessee and who is actively engaged in the treatment of diseases of the human eye, or a licensed, registered optometrist, certifying that such person meets the requirements stated above is required.

Type 198 - Resident Disabled Veteran Hunting & Fishing License **Required certification of recent date from the Veterans Administration must accompany this application.**

In accordance with TCA 70-2-104 (a)(2 & 4b) Applicants who by reason of service in any war are thirty percent (30%) or more disabled or who are one hundred percent (100%) permanently and totally service connected disabled. A certification from the veterans' administration as separate documents or in the form of a certificate or DD214 form is required.

Furthermore, I agree to surrender this license should I become ineligible under the provisions above.

Type 199 - Resident SSI Intellect Disabled Fishing License

In accordance with TCA 70-2-104 (b)(2). Applicants who receive social security benefits due to intellectual disability is entitled to the privilege of sport fishing. Certification from the Social Security Administration that he/she receives SSI benefits due to intellectual disability is required.

Type 450 - Resident Guide License &

Type 455 - Non-resident Guide License

A guide is any individual who accepts compensation for providing assistance to another in any act of hunting, fishing and/or trapping and shall be required to possess a guide license in addition to any other required license. Entities employing individuals as guides may purchase such resident and non-resident guide licenses as may be necessary for its employees.

Resident Licenses

A Social Security Number is required to purchase a Tennessee hunting or fishing license.

Resident licenses can be purchased by:

- Persons who possess a valid Tennessee driver's license or Tennessee state ID issued by the Department of Safety. Tennessee state law requires drivers to obtain a Tennessee drivers license within 30 days of residency.
- Persons who do not drive or do not possess a valid driver's license from another state, but who have lived in Tennessee for 90 consecutive days with the genuine intent of making Tennessee their permanent home, may prove residency by presenting to a TWRA license agent any two of the following documents:
 - current Tennessee Voter Registration card
 - current Tennessee vehicle registration or title
 - Form I-94 issued by the US Citizenship & Immigration Service
 - current rental/mortgage contract or receipt including deed of sale for property or receipt for payment of Tennessee real estate taxes within last year.
