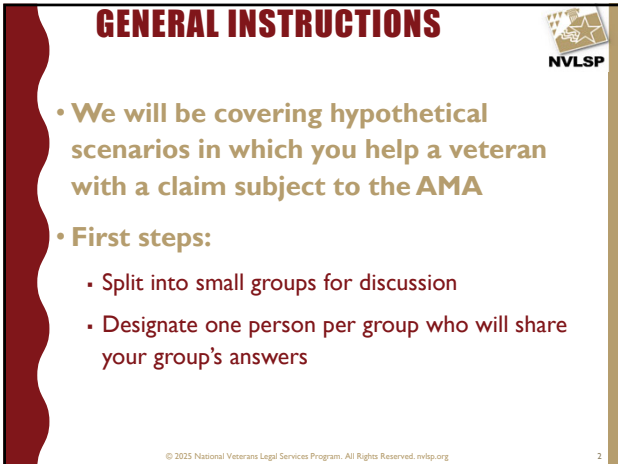

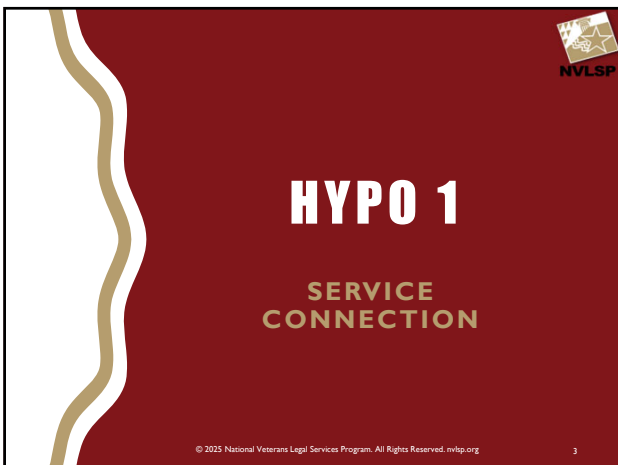

**REVIEWING CLAIM STATUS** 

- You gain access to her claims file and review it
- 7/25/2023: Jean filed VA Form 21-526EZ
  - She sought service connection for “GI problems – diarrhea, cramping, etc.” but didn’t submit medical records
- 10/7/2024: RO issued notice of 9/28/2024 rating decision
  - Denied the claim, finding no current disability
    - No medical evidence shows current treatment for a GI condition
- 12/2/2024: Jean filed VA Form 10182
  - Chose BVA hearing lane

**REVIEWING EVIDENCE**



- **You closely review the evidence on file:**
  - Military personnel records show she served from 2005 to 2009, with one deployment to Afghanistan
  - STRs show one instance of diarrhea and abdominal distress shortly after returning to U.S. from deployment
  - CAPRI records from 2015 to 2021 do not contain a GI diagnosis
  - In a VA Form 21-4138, Jean stated she has experienced frequent episodes of cramping, diarrhea, gas, and bloating since service
  - VA did not offer her a C&P exam before denying the claim

**INTERVIEW WITH VET**



- **Medical treatment:**
  - Jean says she told a private doctor about her symptoms a few years ago, and the doctor suggested that she try Imodium
  - She has been treating herself with OTC medications like Imodium ever since
- **Lay statements:**
  - She says her husband has witnessed her symptoms
  - They have been together since 2008

**VA DEVELOPMENT**



- Jean withdraws her BVA appeal and files a Supplemental Claim on 10/6/2025
  - You submit argument that VA should provide a C&P exam
  - You help Jean submit a VA Form 21-4142
- VA obtains Jean's private treatment records
  - Although there are only a few, one from 5/2022 includes a notation of "R/O IBS" and results of associated testing, but Jean did not return to the doctor
- VA orders a VA exam, and the examiner
  - Diagnoses IBS and states Vet has likely had IBS since at least 5/2022
  - Opines that the "IBS is less likely than not related to service, because the cause of IBS is not definitely known in the medical community"

**RATING DECISION**



- VA grants SC on a presumptive basis under 38 U.S.C. § 1117 and 38 C.F.R. § 3.317
- VA assigns a 30% rating (highest schedular rating available for IBS)
- VA assigns an effective date of 10/6/2025, the date of her supplemental claim

**MEETING WITH CLIENT**

**• Ben – Navy Vet w/ TDVS POA**

**• Considering filing a claim for an increased rating of his major depressive disorder (MDD), one of his two SC disabilities (the other is tinnitus, rated 10% disabling)**

- MDD (DC 9434) is rated 30% disabling under the General Rating Formula for Mental Disorders, effective 7/1/2015
- He says that his symptoms have gotten worse in the last year

**MEETING WITH CLIENT**



- He filed a claim for an increased rating of his MDD in 2020, which was denied in 2021, and he did not seek review of that decision
- Ben is nervous that if he applies for an increase, VA might decrease his MDD rating, and in turn his overall combined rating of 40%
  - He receives additional compensation for his dependents (wife and school-age daughter), which would end if his combined rating is reduced below 30%

**FILING A CLAIM**



**• You ask him more about his symptoms**

- He has panic attacks every couple of days
- He has become more isolated. He has no desire to stay in touch with old friends or make new friends. He spends most of his time on his couch, playing video games or napping.
- He has an “okay” relationship with his wife and daughter, but it has become more strained as he has become more distant

**FILING A CLAIM**



**• Ben’s symptoms (cont’d)**

- He often feels depressed and that he can’t handle being around other people, so he takes many days off
  - He is self-employed as a handyman
- On the few occasions he does accept a job, more and more, he finds himself forgetting how to make certain repairs that used to be second nature to him. He often has to refresh his memory by watching YouTube videos. He sometimes forgets to send the customer a bill for his work.
- Rather than seeking professional care, he has been drinking alcohol and smoking marijuana as a way to cope with his symptoms

**EMPLOYMENT INFO**



- Ben tells you he usually works 2 or 3 days a week
- He earns about \$300-\$500 a week
  - Annually, this is probably a little over the poverty threshold of \$16,320
- He has a high school education
- Ever since leaving the Navy, where he served as an Engineman, he has worked as a handyman, sometimes for a company, but on his own for the past few years

**FILING THE CLAIM**



- On 9/30/2025, you file an ITF for Ben
- On 12/15/2025, you file complete claims for an increased rating for MDD and TDIU using VA Forms 21-526EZ and 21-8940, with supporting evidence including:
  - Lay statements from him and his wife detailing his symptoms and their impact on his ability to work
  - Records documenting income of \$18,900 from his handyman business over the past year
  - A DBQ completed on 10/15/2025 by a local psychiatrist, documenting MDD symptoms and occupational and social impairment consistent with a 50% rating

**VA ACTIONS**



- VA schedules Ben for a mental health conditions contract exam on 2/20/2026
  - The examiner finds that his symptoms and level of occupational and social impairment are consistent with a 50% rating
- On 4/2/2026, VA issues notice of a rating decision dated 3/30/2026:
  - Granting a 50% rating for MDD, effective 2/20/2026
  - Denying entitlement to TDIU, because Ben does not meet the rating percentage requirements of § 4.16(a) and his income is above the poverty threshold

**HLR REVIEW**



- The VA emails you a link to self-schedule the conference. You participate in the conference and present argument to the reviewer.
- On 9/23/2026, the HLR issues a decision:
  - Granting an effective date of 9/30/2025 for the increased MDD rating
  - Continuing the denial of TDIU, because it doesn't consider the Ben's work as a handyman to be "protected employment"

**NEW EVIDENCE**



- Ben chooses the **BVA Direct Review** lane and you file the **VA Form 10182** on **8/13/2027**. You submit argument in support of his claim.
- On **9/30/2027**, Ben tells you he was able to obtain a great opinion from a vocational expert about why his **MDD** prevents him from obtaining or maintaining a substantially gainful occupation and that his self-employment should be considered to be in a protected environment

**RESOLUTION**



- Ben appeals to the **CAVC**, which finds that the **BVA** misapplied the law regarding employment in a protected environment and remands the case for the **BVA** to apply the law correctly
- In **2032**, **BVA** finally grants the veteran entitlement to extrashedular **TDIU** under **38 C.F.R. § 4.16(b)**, based on employment in a protected environment
- In **2033**, the **RO** implements that decision and assigns an effective date of **9/30/2025** for **TDIU**
