We also have the election of our 2026 officers the board development committee this year developed an application process by which you could apply for any position.

And they have pulled together those applications and have a slate of officers that

they'll present to us and we'll vote on those.

Let's see.

And then we have at the very end we've got a little bit of time for certificates that we're going to be out awards for those who have served and then we will call the meeting adjourned.

By both the federal statute and the executive order the representative of the state Department of Education is a voting ex officio member.

The the secretary will call the voting members first and then call the ex officio.

The ex officio votes though are more just an advisory vote.

They don't.

They can't help us reach forum.

They can't sway the results of the vote.

Thanks for clarification.

Thank you.

Appreciate that.

Any other questions or concerns yes gin?

I was gonna clarify we use sometimes when we don't have physically present.

You have to do a roll call vote if you're allowing online participation.

Our first order of business activity is approval of the minutes of the meeting on August the 8th 2025 you should have received a link to these minutes last week and a copy today.

With your packet let's take just a minute and review.

Does anyone have any corrections or additions?

Do I hear a motion to approve?

Nathan Betty second.

All in favor yay.

Yeah.

Any opposed nay?

OK.

Thank you.

Jean would you please give us your director 's report.

Sure thank you.

Thank you.

So a couple things.

As you all probably know there's a government shutdown.

Under a rock in a cave at the bottom of the ocean.

So.

So far that has not impacted volunteer Tennessee or volunteer Tennessee 's partner

programs and we don't expect that it will because all of the money.

For volunteer Tennessee 's operations.

And the pass through money that goes out to the partners in the community was under last year 's appropriations and was so it's already been approved by Congress and the money has already been granted to volunteer Tennessee.

So we don't expect any interruptions to the current program year or the current operations for volunteers in the seat.

But that doesn't mean to say that there aren't lots of challenges associated with the shutdown for folks at the local levels particularly.

Family members.

The AmeriCorps members get a very very small living allowance.

It's not a whole lot of money and a lot of those members rely on things like food stamps to be able to to do their year service.

Because it really isn't just a small amount of money.

So that's having an impact for individual members at the local level.

The the appropriations for the federal fiscal year that we're in right now.

That hasn't been approved which is why we're in the shutdown because they haven't approved that budget yet.

The the Senate version would essentially be level funding the house version would cut the program airport funding by about half the president 's budget includes essentially wind down funding for the agency.

I would expect that out of all of this stuff that probably what will happen.

And once they do end the shutdown is that there would be a continuing spending resolution that essentially would be last year 's funding which would be level funding they may make some tweaks here and there but usually when they do what's called a CR.

Is they just use last year 's budget and say this is what you have for this year 'cause I think it's unlikely that they're gonna be able to do individual appropriations for individual federal agencies especially since we're already in November?

So that would be good if we're funded at last year 's levels it would be level funding so that that's good news.

So one note I'll kind of moving off of a mayor corps the executive committee created an ad hoc committee to look at the process by which.

Donations to friends of volunteer Tennessee flow to volunteer Tennessee.

And you know how that process works.

And so they formed an ad hoc committee and I think that ad hoc committee would probably welcome anybody else who wants to be on that ad hoc committee.

So if you're interested in that.

Just talk to talk to Nathan.

He's carrying that committee.

At the first meeting is what the 17th week.

That I believe.

Thanks Linda.

Yeah thanks Chad.

Is new?

Oh the 10th.

Yes sorry sorry it's yeah it is it's Monday.

So if you're interested in being on that committee just let Nathan know.

And then I can forward you the the meeting invitation I will say just as a side note we're switching over to using Webex webinar and it will be our first time using that for that meeting.

So just be patient as we figure that new system out.

Let's see.

The governor 's volunteer stars awards and the comprehensive conference on volunteers and service learning the dates are set.

For March.

8th and 9th.

So the GDSA will be on the 8th which is Sunday.

We're trying to figure out how to do the conference instead of having the conference.

Monday Tuesday having it start Sunday afternoon and the Holiday Monday and then be done.

We discussed this a little bit earlier when destiny asked about if the changes to the conference would help attendance.

That's one of our goals is to try and help attendance but also we think it will potentially be a little less expensive if we do.

Monday 'cause we're already using the space on Sunday or the governor 's volunteer stars awards so just mark that down in your calendar.

I'll be at the same place.

Yes it's it's going to be at the same place that the Franklin area.

Yeah the the last thing I'd like to note is.

The.

Last year friends of volunteer to see apply for a small grant for a member assistance fund and friends matched that money with some of its own money to be able to help American members who were having some sort of financial difficulty.

During their term of service and this is for the the 2425 service year that ended a few months ago but there were 5 applications that were funded.

A total of 12 were received.

And they distributed \$750.00 out of that fund and you can see here the breakdowns most of it was for transportation.

And then there's a couple other things medical housing.

Demographics take a look at that.

That most of these were.

Fairly young folks.

And you can see they were the split part time full time a little more than half were part-time members.

Not to be.

That's it for the well it lists the programs where the members were that actually got money.

Anyway this is a good thing.

There's money still left in that in that fund because we didn't use all of it.

And it's continuing into this year and so we expect with all of the stuff that's going on that I mentioned earlier difficult to swim airport members that hopefully folks will take advantage of this.

So I just wanted to note this is a a great.

Thing that volunteer exhibit C is done in partnership with friends and with Americas service commissions.

Because Americas service commissions worked to get the they their had the application process for the the.

Matching funds was through America 's service commissions.

And so we got a small grant from them to to get this going.

Jim in light of the situation at federal level do we want to be buying our americorp members that we do have this as a fall back for them.

I don't know how much funding is left over in the future just a couple dollars and there's no sense doing it.

But if there's some significant funding left maybe you want to reach out to programs to remind them.

I believe that went out at the beginning of the the program year to the mayor Corp. Program managers I mean we can we can send it typically what we would do is we'd send it a couple reminders during the year.

Because.

Yeah yeah I don't remember when the last time we reminded them about it but we can certainly send out a reminder.

Yeah so anyway that I think that's yeah sorry one last thing I did the person who was supposed to do the inspirational moment sent me some statistics for this is for the United way of South Central Tennessee which covers.

Rutherford County and I think Canon county and I think one more county.

Sorry I don't remember right off hand which one it is but through their Tennessee serves sub portal they had 110.

Agencies registered and for the volunteers they had 4400 registered volunteers and they they also use the platform for their days of action.

So they're stuck.

The bus baby basics and their volunteer week.

So just a couple things for the person who was supposed to come and tell us a little bit about how they're using the Tennessee service board.

Thank you Jean.

Well thanks for all your hard work we really.

Showed up.

And now I'd like to call on James to give us an update on friends please.

Thank you all for your.

Time and I just appreciate it through honor to be on that Commission and and on top of that I like the chair of friends of volunteer Tennessee and.

Last month I conducted our first.

Friends of volunteer board meet meeting as chair.

I appreciate the the board feed so supportive because I'm just lying and by the seat of my pants.

But having been on the board and I appreciate all the members over the past few years I've learned a lot from the members 2 years.

As view chair I took an effort to start the new meeting and I'd like to make it a Florida bar regular meeting to the beginning each board meeting with just a statement of the friends of volunteer just there's a constant reminder before.

That this is the focus of our any discussion that we have that our mission be.

Read by one of the members and that is to encourage volunteerism and community service by supporting the programs services of volunteer Tennessee and this includes fostering volunteerism for training.

Collaboration to address.

Community needs.

Just appreciate just the opportunity to start off every meeting being focused in that way and we had some of the things that we've covered over the past year particularly just last month we we had a scholarship recipient for the TNCBA scholarship sit in for. An exam in the fall and the volunteer Tennessee awarded \$200.00 scholarship the last balance has of the end of this is important because if we want to help volunteer Tennessee in the programs but we need funds to do that and so.

As of the end of.

Of last month we had a total of.

As we end of September actually \$4469.00 in our budget.

And for October we generated a total of \$1665.00 in donations through network for good and an additional \$85.00.

And now you have got I.

Don't have the permission I have asked permission for.

A board member here but that person generally.

I don't need a \$200.00 yesterday.

I appreciate that very much.

I hope that motivates us all to contribute.

What we can?

Now as you know we had a volunteer specialty license plate program.

And in order for that to be a success we had to have at least 1000 people sign up for the purchase.

The license plate had disappointingly we didn't get 1000 person goal.

So.

We discontinued that that initiative.

And.

So we we've contacted those who have already purchased the license plate in advance giving them the choice for full refund of the friends or friends retaining their money and we would send them the novelty version of the license plate.

But on the front of their cars now I have the 119 people that.

Initially made the orders we so far refunded 43.

And so for those that did get don't get a refund or or at least they've acknowledged that they they said you can keep our money.

We are going to send them this plate to put on front of theirs their cars.

Disappointingly the plates that were produced I think we have 100 of them came out not looking like a license plate that you.

It's a.

So small.

So we're currently in touch with the the company that printed these and to.

And they've acknowledged that it's not up to standard it's supposed to look like a license plate fill the whole thing.

So we'll know by the end middle of this month whether they're gonna redo these for us and they're charging those that have already received this unusual looking plate.

We would send them a new one.

And that's gonna be the collector 's edition.

But I'm determined that we can make something creative out of this if we snip it and round it out turn into a pencil holder.

I don't care.

We've got something.

And we'll try to sell these at the upcoming conference in March.

But also promote them in other ways.

Now talk about funding.

We one of our members.

Jay Sanders who works for a Middle Tennessee electric.

He's in charge of charitable foundation and he's generously making the effort to put forward that we would receive a \$10,000.00 grant and I know there's been a lot of questions like.

Sure.

Well.

If we get these funds can we sit on them for a while in case suddenly volunteer Tennessee needs them and the feedback that we've gotten is he's not writing anything into the grant that would limit us?

From doing whatever we want with funds so.

So at our next meeting we'll be discussing like how we can use those resources but at the at the earliest maybe those resources would come in about January.

Ah.

Other issues.

We we want to step up.

Wanna.

I want to be a little more ambitious that my friends are volunteer.

I wanna be a little more ambitious that my friends volunteer.

Tennessee can really be the support that would our our mission declares us to be to be a support to volunteer Tennessee in the programs and initiatives that we're involved in and in order to do that we need to expand.

Our visibility in the public in a variety of ways.

So we're moving to.

Expand I've already made some business cards.

I mean I've talked to the our board and see if they approve of these if they think they're suitable but if in my opinion I think everybody on our board should have friends of volunteer business cards be handing them out to let people know who we support and.

What we're all about?

Communicate that on a regular basis.

In addition we've expanded our social media and we can pop that up.

Kim 's looking for that but on Facebook that's not ours.

Oh that that will take you to the donation.

That'll take you to the donation.

Yeah I I created the QR code a.

Few minutes alright to the donation OK we're.

Gonna require that before you get your lunch next time.

Thank you that.

Appreciate that.

This is our new friends of volunteer Tennessee Facebook page and I just.

I set it up.

There's our our license plate as it should look if you open it up on your page you'll probably get the whole screen.

Or you can click on that and see what it looks like.

And for as soon as I set it up I just went crazy.

I just went through.

I went to volunteer Tennessee and looked at all the organizations that were supporting and promoting or partnering with and I just started liking everything they do and following them.

So I got up to 92 followings.

And then from that people started seeing I was sharing their stuff and I was celebrating their stuff trying to write comments about the activities and volunteer activities.

That they're doing.

And they started following so I would encourage everyone the only way this works I could share but I'm just one person the only way these any of these posts get visibility is all of us getting on there and following it.

And clicking on it and liking just a single light goes a long way in making it more visible for a longer period of time on the Internet.

So we want to look at for other platforms sharing on our LinkedIn profiles.

And whatever we can to just get the word out and I'm just amazed you know I I look at the stat say on LinkedIn every time I share something it tells me how many people viewed it and which corporations they're from.

And it tells me what part of the state or what type of industry they're from whether it's state or.

Or or tourism or whatever it is.

And to me that's very helpful.

It's like what did I include in that post that attracted these people to that particular post that they wanted to like it.

Or applaud it or share it.

And so.

But if you're getting on there and and liking it and sharing it it's not to increase my popularity.

I don't care at all.

It's to to make these to celebrate volunteerism and that's where we want to go for in addition we want to use some of the fundings that are coming in I want to be involved in not just myself would hope at least one other person on our board could. Be a member of the state Chamber of Commerce to be involved in in interacting I mean it's one thing we do.

We're doing it right now.

Virtual meetings but nothing matches.

Compares with meeting people face to face and when you're involved in the Chamber of Commerce when I was working for the Department of Labor and workforce development I was there every week I went to their orientation every week.

Not because I had something new to learn but I always.

He's met new people and I was always engaging with new people and the other programs that go.

So I think it's very important that we have a place at the table Chamber of Commerce and it opens a lot of doors when you're a fellow member of the Chamber of Commerce.

And and people are more interested in talking.

In addition we'll get a fancy table and we want a fancy tablecloth.

And we want to be involved in as many programs as possible.

I think the week that I was elected chair I went directly out to the park Centennial park in in Nashville and I went out and visited every volunteer at that volunteer week tables they were so much fun.

Everyone of them had a story tell I took pictures with.

Them and I think this is the kind of engagement that we want to work work on and.

You know I understand.

Every member is.

I'm not retired like me.

I'm enjoying my retirement because I can get more involved.

But whatever time we have and just sharing a business card or just talking it up or just liking something on Facebook goes a long way.

In in promoting and celebrating volunteers across Tennessee and then lastly we are moving.

In our we want to expand our our friends event.

Volunteer Tennessee in helping Candace.

And and whatever she needs and her capacity to reach out to companies I'll be talking next month about expanding our capacity to reach out to the county.

We call them county coordinators.

And getting more counties involved and and stirring up interest.

And.

And.

And just in any way we can.

And also the Super volunteers our capacity to help in that outreach as well.

It's all about celebrating and and if you enjoy what you see it's not work it's it's really a lot of fun to see.

I used to tell when I was at high school.

Volley track coach I used to tell all my athletes I said my job as your coach is to make you fence.

I said.

You get out there and do the best job you can do and I will make you so popular on social media.

Everybody will know what race you want and when you did that and that's what we're doing.

We are essentially Buick friends as a booster club and we're here to celebrate and work as closely with volunteer Tennessee to encourage and via support in any way we can.

And there was still some money leftover.

And that's why we then also suggested funding the Chattanooga chamber foundation.

At the time in August.

We still did not have the funding for teach for America Memphis.

I'm sorry not teach for America.

Memphis Memphis teacher residency they were approved for competitive funding but the funding had not actually.

Been.

Granted because the my understanding is that the office of management and budget at federal level was holding those competitive funds not just for MTR but for all competitive America programs across the country.

They finally released those funds.

In August we were proposing to include money in this chart the formula funding to cover that in case that money didn't come through.

Well it did come through so that gives us the current chart which there's no change from the August presentation for the top ones.

And these are the programs that are in the middle of their 3 year funding process. So they're either in.

Year 2 or year 3.

And so there's no change from what we presented in August.

Below the only change in the chart from what was presented in August and then what the executive committee subsequently.

Subsequently approved was.

Taking out Memphis teacher residency because that funding was eventually awarded and so we no longer need to include them in this chart.

All the other numbers did not change.

From what was presented in August and again.

That that because we didn't have a quorum at the August meeting the executive committee met and reviewed this and approved the the previous version.

And then we take that federal notice of opportunity and we turn it into a Tennessee specific notice of funding opportunity and put that out to nonprofits in the state or nonprofits government agencies that want to apply for Maricopa funding.

Well we still don't have it.

That federal notice.

So what we have done for the competitive programs because their due date is earlier than the formula deadline we provided.

The competitive programs with essentially last year 's notice.

And told them it's probably when it does get released it's probably not gonna look exactly like this but we don't know exactly what it's gonna look like and we don't wanna wait until the last minute to get it to you.

So we recommend that you go ahead and start working on your applications based on last year.

's and.

Because the federal notice isn't.

Active they can't submit those applications online so they're gonna have to submit them to us directly through a digital format and then we're gonna review those and make some recommendations and comments and changes.

So we're doing our best to try and get the competitive applicants ready for bless you

a due date that we expect will probably be in early January for the competitive. The formula.

Can do upstate formula funding process without the federal notice because it's up to this body to make the determination on how this formula funds get spent?

But we typically model this the formula off of the federal version just to make sure that that what the Tennessee formula programs is aligned with what the the federal agency is looking for in terms of their their priorities that kind of thing.

But we've got time for that because the formula deadline typically is is later.

But all of that's to say that this timeline is still not right because we still don't have this embargoed funding notice of funding opportunity.

So.

The the thing that you all have already approved which is the key thing. Is the stuff at the top of this which is essentially which programs to send to the competitive process and which ones to keep in the formula?

You've already approved that and that's what we're going.

That's what staff is doing.

We're we're going based on what you've already approved at the top.

Because again the timeline itself is out the window.

So that's what we're working on.

So I think that's a long way of saying that you can vote on this version.

But when we put this version together we had hoped that we would have the notice by the 13th of October and we still don't have it.

So you can vote on this timeline but we're gonna have to change it again.

So I think you can.

I think it would be safe to table it I mean again we we really hope that by now we would have it and we could get you a real timeline but it's just not there yet.
