Dillard's has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure. The closure is expected to occur on January 17, 2025, and no later than January 31, 2025. The affected location is Stones River Mall, 1720 Old Fort Parkway, Murfreesboro, TN 37129. The total number of affected workers is 75. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on November 15, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Northern Middle Local Workforce Development Board's rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight
