GEODIS Logistics, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure effective July 31, 2025. The total number of affected workers is 40. This company is located at 549A Aldi Blvd, Mt Juliet, TN 37122. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on June 9, 2025.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle Local
