ProCare Private Duty has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure on November 14, 2024. The affected location is 1907 N. Roane Street, Ste. 409, Johnson City, TN. 37601. The total number of affected workers is 29. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on November 15, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Northeast Local Workforce Development Board's rapid response team, employed by the First Tennessee Development District, has been notified to coordinate services with the employer and affected employees. The Northeast Local Workforce Development Board will be responsible for the
